After consideration on the merits, the Committee recommends the following:

HB25-1293 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 5, strike "**revisions.**" and substitute
2 "**revisions - notice to revisor of statutes.**".

3 Page 2, line 6, strike "2026," and substitute "2028,".

4 Page 2, after line 17 insert:

5 "(c) (I) THE REQUIREMENT TO COMPLETE THE DUTY DESCRIBED
6 PURSUANT TO SUBSECTION (2.9)(a) OF THIS SECTION ON OR BEFORE JULY
7 1, 2027 IS CONTINGENT ON MONEY BEING AVAILABLE TO PERFORM THE
8 DUTY ON OR BEFORE JULY 1, 2027. IF MONEY IS NOT AVAILABLE FOR THE
9 STATE BOARD, THE DEPARTMENT OF EDUCATION, OR ANY OTHER ENTITY
10 NECESSARY TO PERFORM THE DUTY REQUIRED PURSUANT TO SUBSECTION
11 (2.9)(a) OF THIS SECTION ON OR BEFORE JULY 1, 2027, THE STATE BOARD
12 IS NOT REQUIRED TO PERFORM THE DUTY UNTIL ON OR BEFORE JULY 1,
13 2028, PURSUANT TO THE STANDARD SCHEDULE DESCRIBED IN SECTION (6)
14 OF THIS SECTION.

15 (II) THE REQUIREMENT TO COMPLETE THE DUTY DESCRIBED
16 PURSUANT TO SUBSECTION (2.9)(a) OF THIS SECTION ON OR BEFORE JULY
17 1, 2027 TAKES EFFECT IF THE STATE BOARD RECEIVES TWENTY THOUSAND
18 DOLLARS OF GIFTS, GRANTS, OR DONATIONS FOR THE PURPOSES OF THIS
19 SECTION (2.9) ON OR BEFORE JULY 1, 2026. THE COMMISSIONER OF THE
20 DEPARTMENT OF EDUCATION SHALL NOTIFY THE REVISOR OF STATUTES IN
21 WRITING OF THE DATE ON WHICH THE CONDITION SPECIFIED IN THIS
22 SUBSECTION (2.9)(c)(II) HAS OCCURRED BY EMAILING THE NOTICE TO
23 REVISOROFSTATUTES.GA@COLEG.GOV."

24 Page 3, strike lines 4 through 6 and substitute "including a student. ~~but~~
25 ~~shall only furnish an opiate antagonist to a student if the student has~~

- 1 ~~received appropriate school-sponsored training."~~
- 2 Page 4, strike lines 3 and 4 and substitute "STUDENTS."
