After consideration on the merits, the Committee recommends the following:

SB25-034 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 3, line 19, strike "**definitions.**" and substitute
2 "**notice to revisor - definitions.**".

3 Page 5, after line 24 insert:

4 "(7)(a) THE DEPARTMENT MAY SEEK, ACCEPT, AND EXPEND GIFTS,
5 GRANTS, OR DONATIONS FROM PRIVATE OR PUBLIC SOURCES TO DEVELOP
6 AND MAINTAIN THE ONLINE PORTAL DESCRIBED IN SUBSECTION (2)(b) OF
7 THIS SECTION. THE DEPARTMENT SHALL NOT IMPLEMENT THIS SECTION
8 UNTIL IT RECEIVES TWO HUNDRED THOUSAND DOLLARS OF GIFTS, GRANTS,
9 AND DONATIONS FOR THE ONLINE PORTAL.

10 (b) NOTWITHSTANDING SECTION 24-75-1305, FOR STATE FISCAL
11 YEAR 2026-27 AND ANY SUBSEQUENT FISCAL YEAR, THE GENERAL
12 ASSEMBLY MAY APPROPRIATE MONEY FROM THE GENERAL FUND FOR THE
13 ONLINE PORTAL.

14 (8) SUBSECTIONS (1) TO (6) OF THIS SECTION WILL TAKE EFFECT IF
15 THE DEPARTMENT RECEIVES TWO HUNDRED THOUSAND DOLLARS OF GIFTS,
16 GRANTS, OR DONATIONS TO DEVELOP AND MAINTAIN THE ONLINE PORTAL
17 DESCRIBED IN SUBSECTION (2)(b) OF THIS SECTION. THE EXECUTIVE
18 DIRECTOR OF THE DEPARTMENT OF PUBLIC SAFETY SHALL NOTIFY THE
19 REVISOR OF STATUTES IN WRITING OF THE DATE ON WHICH THE CONDITION
20 SPECIFIED IN THIS SUBSECTION (8) HAS OCCURRED BY EMAILING THE
21 NOTICE TO REVISOR OF STATUTES.GA@COLEG.GOV. SUBSECTIONS (1) TO (6)
22 OF THIS SECTION TAKE EFFECT UPON THE DATE IDENTIFIED IN THE NOTICE
23 THAT THE DEPARTMENT HAS RECEIVED TWO HUNDRED THOUSAND
24 DOLLARS OF GIFTS, GRANTS, OR DONATIONS FOR THE ONLINE PORTAL OR,
25 IF THE NOTICE DOES NOT SPECIFY THAT DATE, UPON THE DATE OF THE
26 NOTICE TO THE REVISOR OF STATUTES."

1 Page 7, line 2, strike "This" and substitute "(1) Except as provided in
2 subsection (2) of this section, this".

3 Page 7, after line 10 insert:

4 "(2) Sections 24-33.5-424.5 (1), (2), (3), (4), (5), and (6),
5 Colorado Revised Statutes, as enacted in section 3 of this act; section
6 18-12-111 (4), Colorado Revised Statutes, as enacted in section 4 of this
7 act; and section 5 of this act shall only take effect upon receipt of the
8 notice to the Revisor of Statutes required by section 24-33.5-424.5 (8),
9 Colorado Revised Statutes, as enacted in section 3 of this act."
