- Page 3, line 21, strike "DECEMBER 31, 2025," and substitute "JUNE 30,
 2026,".
- Page 3, lines 23 and 24, strike "CONVENE A STAKEHOLDER GROUP" and
 substitute "CONSULT WITH STAKEHOLDERS".
- 8 Page 4, strike line 7 and substitute "INCLUDING FUNDING FOR TREATMENT
 9 IN PLACE IDENTIFIED BY STAKEHOLDERS.".

11 "(b) AT A MINIMUM, THE STAKEHOLDERS CONSULTED WITH 12 PURSUANT TO SUBSECTION (2)(a) OF THIS SECTION MUST INCLUDE 13 REPRESENTATIVES FROM COMMUNITIES THAT HAVE EXISTING RESOURCES 14 AND PROGRAMS; COMPREHENSIVE COMMUNITY BEHAVIORAL HEALTH 15 PROVIDERS; ESSENTIAL BEHAVIORAL HEALTH SAFETY NET PROVIDERS 16 THAT FURNISH CRISIS SERVICES; REPRESENTATIVES FROM LOCAL 17 PROGRAMS RELEVANT TO THE COMMUNITY, SUCH AS FAMILY RESOURCE 18 CENTERS, DOMESTIC VIOLENCE PROGRAMS, SUBSTANCE USE TREATMENT 19 PROVIDERS, AND INDEPENDENT CLINICIANS OR QUALIFIED UNLICENSED 20 INDEPENDENT PROVIDERS; REPRESENTATIVES CERTIFIED IN PEDIATRIC 21 HEALTH CARE; REPRESENTATIVES FROM AGENCIES PROVIDING LAW 22 ENFORCEMENT AND FIRE PROTECTION; REPRESENTATIVES FROM AN ORGANIZATION REPRESENTING EMERGENCY MEDICAL SERVICES,
 EMERGENCY RESPONSE SERVICES, OR THE STATE EMERGENCY MEDICAL
 AND TRAUMA SERVICES ADVISORY COUNCIL CREATED IN SECTION
 25-3.5-104; AND ANY OTHER REPRESENTATIVES THE DEPARTMENT AND
 BEHAVIORAL HEALTH ADMINISTRATION DETERMINE ARE NECESSARY.".
