SB25-072 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 5, line 2, after "(1)" insert "(a)".
- 2 Page 5, line 6, strike "A" and substitute "A MANUFACTURER MAY INCLUDE
- 3 IN AND OBTAIN A SINGLE REGISTRATION FOR MULTIPLE KRATOM PRODUCTS
- 4 THAT CONTAIN THE SAME KRATOM INGREDIENTS AND THAT ARE IN THE
- 5 SAME DELIVERY FORM BUT THAT ARE IN DIFFERENT CONTAINERS,
- 6 PACKAGES, OR VOLUMES.
- 7 (b) A".
- 8 Page 5, line 14, after "FROM" insert "AN AUDITOR ACCREDITED BY".
- 9 Page 8, after line 13 insert:
10 **"44-15-107. Local government regulation.** NOTHING IN THIS
11 ARTICLE 15 OR RULES ADOPTED BY THE EXECUTIVE DIRECTOR PURSUANT
12 TO THIS ARTICLE 15 LIMITS THE ABILITY OF A LOCAL GOVERNMENT TO
13 ENACT OR ENFORCE AN ORDINANCE, RESOLUTION, REGULATION, OR OTHER
14 LAW RELATING TO THE MANUFACTURE, SALE, OFFER FOR SALE, TRANSFER,
15 POSSESSION, OR USE OF ANY KRATOM PRODUCT WITHIN THE LOCAL
16 GOVERNMENT'S JURISDICTION SO LONG AS THE LOCAL GOVERNMENT
17 ORDINANCE, RESOLUTION, REGULATION, OR LAW IS NO LESS RESTRICTIVE
18 THAN THE REQUIREMENTS OF THIS ARTICLE 15."

20 RISK OF ADDICTION;"
- 21 Page 9, line 18, strike "MEDICATIONS;" and substitute "MEDICATIONS,
22 DRUGS, AND CONTROLLED SUBSTANCES;"

- 1 Page 9, line 19, strike "STATEMENT: "THESE" and substitute
2 "STATEMENTS:
3 (A) "THESE".
- 4 Page 9, line 20, strike "UNITED STATES".
- 5 Page 9, after line 22 insert:
6 "(B) "KEEP OUT OF REACH OF CHILDREN."; AND".
- 7 Page 9, after line 25 insert:
8 "(B) THE NUMBER OF RECOMMENDED SERVINGS PER PACKAGE;".
- 9 Reletter succeeding sub-subparagraphs accordingly.
