After consideration on the merits, the Committee recommends the following:

SB25-081 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 8, after line 6 insert:
- 2 "(a) A TRANSPORTATION INFRASTRUCTURE PROJECT;
- 3 (b) AN INFRASTRUCTURE PROJECT IN A TRANSIT-ORIENTED
- 4 COMMUNITY;
- 5 (c) A COUNTY COURTHOUSE FACILITY;"
- 6 Reletter succeeding paragraphs accordingly.
- 7 Page 8, line 14, strike "STOCK;" and substitute "INFRASTRUCTURE;"
- 8 Page 9, line 9, strike "NINE" and substitute "ELEVEN".
- 9 Page 9, after line 18 insert:
- 10 "(V) A REPRESENTATIVE OF LOCAL GOVERNMENTS, APPOINTED BY
- 11 THE GOVERNOR;"
- 12 Renumber succeeding subparagraphs accordingly.
- 13 Page 9, line 25, strike "EMPLOYEES;" and substitute "EMPLOYEES,
- 14 APPOINTED BY THE STATE TREASURER;"
- 15 Page 10, line 1, strike "AND".
- 16 Page 10, line 3, strike "TREASURER." and substitute "TREASURER; AND
- 17 (XI) AN INDIVIDUAL WITH A BACKGROUND IN COMMERCIAL
- 18 LENDING REPRESENTING AN INSTITUTION INSURED BY THE FEDERAL
- 19 DEPOSIT INSURANCE CORPORATION, APPOINTED BY THE STATE

1 TREASURER."

2 Page 17, after line 11 insert:

3 "(7) THE AUTHORITY SHALL ENSURE THAT ANY LOAN THAT IS
4 ISSUED BY THE AUTHORITY AND THEN PAID IN FULL IS CLOSED. THE
5 AUTHORITY SHALL NOT USE A CLOSED LOAN AS EQUITY FOR ANY OTHER
6 PROJECT."

7 Renumber succeeding subsection accordingly.

8 Page 25, line 5, after "AUTHORITY" insert "OR THE DEPARTMENT OF THE
9 TREASURY".

10 Page 28, strike line 17 and substitute: "(15)(b)(XX) and (15)(b)(XXI);
11 and **add** (15)(b)(XXII) as follows:".

12 Page 28, strike lines 21 through 24 and substitute:

13 "(XX) The middle-income housing authority created in section
14 29-4-1104 (1); ~~and~~
15 (XXI) The equal justice authority created in section 13-5.7-202;
16 AND".

17 Page 28, line 25, strike "(XXI)" and substitute "(XXII)".
