After consideration on the merits, the Committee recommends the following:

SB25-205 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 2, lines 7 and 8, strike "FROM THE SHERIFF'S  
2 OFFICE OF THE COUNTY IN WHICH THE LICENSEE MAINTAINS THEIR  
3 FEDERALLY LICENSED PLACE OF BUSINESS".

4 Page 2, line 9, after "INDIVIDUAL." insert "IF A FEDERAL FIREARMS  
5 LICENSEE'S PLACE OF BUSINESS IS LOCATED WITHIN INCORPORATED CITY  
6 LIMITS AND REQUESTS A FIREARM SERIAL NUMBER CHECK, THE LICENSEE  
7 MUST REQUEST THE FIREARM SERIAL NUMBER CHECK FROM THE POLICE  
8 DEPARTMENT WITHIN THE CITY LIMITS IN WHICH THE FEDERAL FIREARMS  
9 LICENSEE'S PLACE OF BUSINESS IS LOCATED. IF A FEDERAL FIREARMS  
10 LICENSEE'S PLACE OF BUSINESS IS LOCATED IN AN UNINCORPORATED PART  
11 OF A COUNTY AND REQUESTS A FIREARM SERIAL NUMBER CHECK, THE  
12 LICENSEE MUST REQUEST THE FIREARM SERIAL NUMBER CHECK FROM THE  
13 SHERIFF'S DEPARTMENT OF THE COUNTY IN WHICH THE FEDERAL FIREARMS  
14 LICENSEE'S PLACE OF BUSINESS IS LOCATED."

15 Page 3, after line 8 insert:

16 "(4) IF THE FEDERAL GOVERNMENT ALLOWS A FEDERAL FIREARMS  
17 LICENSEE TO ACCESS THE FEDERAL GOVERNMENT'S FIREARM TRACING  
18 PROGRAM TO ALLOW THE FEDERAL FIREARMS LICENSEE TO PERFORM A  
19 FIREARM SERIAL NUMBER CHECK, THE FEDERAL FIREARMS LICENSEE MAY  
20 PERFORM THE FIREARMS SERIAL NUMBER CHECK THEMSELF. THE FEDERAL  
21 FIREARMS LICENSEE IS STILL SUBJECT TO THE REPORTING REQUIREMENTS  
22 DESCRIBED IN SUBSECTION (5) OF THIS SECTION. THIS SUBSECTION (4) WILL  
23 TAKE EFFECT AS SOON AS THE TECHNOLOGY AND INFRASTRUCTURE FOR A  
24 FEDERAL FIREARMS LICENSEE TO PERFORM A FIREARM SERIAL NUMBER  
25 SEARCH IS AVAILABLE."

- 2 Page 3, line 17, strike "(4)" and substitute "(5)".
- 3 Page 4, line 6, strike "(4);" and substitute "(5);".
- 4 After "OFFICE" insert "OR POLICE DEPARTMENT" on **Page 2**, lines 11, 17,
- 5 20, and 22; **Page 3**, lines 2, 4, and 7.
