After consideration on the merits, the Committee recommends the following:

SB25-214 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend reengrossed bill, strike "PROGRAM" and substitute "PROGRAM, AS
2 ESTIMATED IN THE FISCAL IMPACT STATEMENT PREPARED PURSUANT TO
3 SECTION 1-40-124.5 FOR THAT REFERRED MEASURE," on: **Page 4**, line 27;
4 **Page 5**, lines 19 and 27; and **Page 7**, line 10.

5 Page 7, strike line 24 and substitute: "OF THE GENERAL ASSEMBLY. IN
6 ADDITION TO THE NOTICE DESCRIBED IN THIS SUBSECTION (1)(b.5)(I), THE
7 DEPARTMENT MAY SUBMIT A SUPPLEMENTAL APPROPRIATION REQUEST TO
8 THE JOINT BUDGET COMMITTEE OR A REQUEST FOR AN OVEREXPENDITURE
9 IN ACCORDANCE WITH SECTION 24-75-111.

10 (II) (A) AS SOON AS PRACTICABLE AFTER THE DEPARTMENT
11 SUBMITS A REQUEST FOR A SUPPLEMENTAL APPROPRIATION PURSUANT TO
12 SUBSECTION (1)(b.5)(I) OF THIS SECTION, THE JOINT BUDGET COMMITTEE
13 OF THE GENERAL ASSEMBLY SHALL INFORM THE DEPARTMENT WHETHER
14 IT WILL APPROVE OR REJECT THE DEPARTMENT'S REQUEST. IF THE JOINT
15 BUDGET COMMITTEE INDICATES THAT IT WILL REJECT THE DEPARTMENT'S
16 REQUEST, THE DEPARTMENT MAY DETERMINE A PRORATED, REDUCED
17 REIMBURSEMENT AMOUNT FOR THE REIMBURSEMENTS THAT THE
18 DEPARTMENT PROVIDES PURSUANT TO SUBSECTION (1)(b) OR (1)(b.3) OF
19 THIS SECTION AS APPLICABLE FOR THE REMAINDER OF THAT BUDGET YEAR.

20 (B) IF, WITHIN THIRTY DAYS OF THE DEPARTMENT SUBMITTING A
21 REQUEST FOR AN OVEREXPENDITURE PURSUANT TO SUBSECTION (1)(b.5)(I)
22 OF THIS SECTION, THE DEPARTMENT'S REQUEST HAS NOT BEEN GRANTED,
23 THE DEPARTMENT MAY".

24 Page 8, line 2, strike "(II)" and substitute "(C)".

25 Page 8, line 3, strike "(1)(b.5)(I)" and substitute "(1)(b.5)(II)(A) AND
26 (1)(b.5)(II)(B)".
