A BILL FOR AN ACT

101 **CONCERNING A REQUIREMENT TO INCLUDE MEASURABLE GOALS THAT**
102 **ARE SUBJECT TO DEADLINES IN COLORADO'S CLIMATE ACTION**

Bill Summary

The bill requires:

- ! The state climate action plan to include specific measurable goals, the achievement of which will either reduce Colorado's greenhouse gas emissions or increase Colorado's adaptive capability to respond to climate

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-20-111, **amend**
3 (2) (a) and (3) (a) as follows:

4 **24-20-111. Climate change position created - duties - report.**

5 (2) The duties of the position created pursuant to subsection (1) of this
6 section include, at a minimum:

7 (a) Development and periodic update of a climate action plan or
8 similar document that sets forth a strategy, including specific policy
9 recommendations AND MEASURABLE GOALS BASED ON THE BEST
10 AVAILABLE SCIENCE, THE ACHIEVEMENT OF WHICH WILL BOTH REDUCE
11 COLORADO'S GREENHOUSE GAS EMISSIONS AND INCREASE COLORADO'S
12 ADAPTIVE CAPABILITY TO RESPOND TO CLIMATE CHANGE, ALONG WITH
13 ASSOCIATED NEAR-TERM, MID-TERM, AND LONG-TERM DEADLINES TO
14 ACHIEVE THE GOALS, that the state could use to address climate change
15 and reduce its greenhouse gas emissions; and

16 (3) (a) The governor or his or her designee shall submit an annual
17 report to the house agriculture, livestock, and natural resources
18 committee, the house transportation and energy committee, and the senate
19 agriculture, natural resources, and energy committee, or any successor
20 committees, on climate change issues generally, the current climate action
21 plan developed under this section, and the specific ways in which climate
22 change affects the state. The report:

23 (I) May address, as appropriate, the correlations between climate

1 change and wildfires, bark beetle infestation, snowpack, water storage,
2 drought, and statewide emissions of greenhouse gases; ~~The report~~ AND

3 (II) Shall include:

4 (A) Information regarding efforts to reduce emissions of gases
5 and to reform practices known to exacerbate climate change effects;

6 (B) ~~The report shall also include~~ Additional prospective proposals
7 to prepare the state for the effects of climate change and proposals to
8 further reduce the factors that contribute to climate change within
9 Colorado; AND

10 (C) AN ANALYSIS OF THE PROGRESS MADE IN MEETING THE
11 MEASURABLE GOALS SPECIFIED IN THE CLIMATE ACTION PLAN, INCLUDING
12 WHETHER COLORADO IS ON TRACK TO MEET THE NEAR-TERM, MID-TERM,
13 AND LONG-TERM DEADLINES SPECIFIED IN THE PLAN. THE ANALYSIS MUST
14 INCLUDE, WITH RESPECT TO EACH OF THE NEAR-TERM, MID-TERM, AND
15 LONG-TERM DEADLINES, AN ESTIMATE OF THE ECONOMIC, SOCIAL, AND
16 HEALTH IMPACT ON LOW-INCOME INDIVIDUALS IN COLORADO THAT
17 RESULTS OR WOULD RESULT FROM MEETING THE DEADLINES AS PLANNED.

18 **SECTION 2. Act subject to petition - effective date.** This act
19 takes effect at 12:01 a.m. on the day following the expiration of the
20 ninety-day period after final adjournment of the general assembly (August
21 10, 2016, if adjournment sine die is on May 11, 2016); except that, if a
22 referendum petition is filed pursuant to section 1 (3) of article V of the
23 state constitution against this act or an item, section, or part of this act
24 within such period, then the act, item, section, or part will not take effect
25 unless approved by the people at the general election to be held in
26 November 2016 and, in such case, will take effect on the date of the
27 official declaration of the vote thereon by the governor.
