**A BILL FOR AN ACT**

101 **CONCERNING MODIFICATIONS TO THE BUSINESS ENTERPRISE PROGRAM**  
102 **TO BE ADMINISTERED BY THE DEPARTMENT OF LABOR AND**  
103 **EMPLOYMENT UNDER ITS AUTHORITY TO ADMINISTER**  
104 **VOCATIONAL REHABILITATION PROGRAMS.**

assistance, and priority to persons who are blind and who wish to operate vending facilities on state property. Under the current program, state property includes any building, land, or other real property owned, leased, or occupied by a department or agency of the state except property owned, leased, or occupied by a higher education institution or the board of commissioners of the Colorado state fair authority.

The bill removes the exception for property owned, leased, or occupied by higher education institutions or the state fair authority, thereby granting priority to persons who are blind and are licensed vendors to operate vending facilities on higher education and state fair authority properties.

Additionally, the bill expands the program to allow persons who are blind and determined qualified to operate other types of businesses on state property.

The bill also changes the criteria for determining when a vending facility or other business cannot be operated by a blind vendor to more closely follow the standard under federal law.

The bill contains a clause specifying that additional appropriations are not necessary to implement the bill.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 8-84-202, **amend as**  
3 **they will become effective July 1, 2016,** (2) [REDACTED] as follows:

4 **8-84-202. Definitions.** As used in this part 2, unless the context  
5 otherwise requires:

6 (2) "Satisfactory site" means an area determined by the  
7 department of labor and employment to have sufficient space, electrical  
8 and plumbing outlets, and other facilities as prescribed by department rule  
9 for the location and operation of a vending facility OR OTHER BUSINESS  
10 OPERATED BY A PERSON WHO IS BLIND.

11 [REDACTED]

12 **SECTION 2.** In Colorado Revised Statutes, **amend as it will**  
13 **become effective July 1, 2016,** 8-84-203 as follows:

14 **8-84-203. Priority for persons who are blind - licensing.** The

1 department of labor and employment shall issue licenses to persons who  
2 are blind and who are qualified to operate vending facilities, in  
3 accordance with the criteria used for the licensing of operators of vending  
4 facilities on federal property pursuant to section 8-84-107 and the federal  
5 "Randolph-Sheppard Vending Stand Act", as amended. IN ADDITION, THE  
6 DEPARTMENT MAY ISSUE LICENSES TO PERSONS WHO ARE BLIND AND WHO  
7 ARE QUALIFIED TO OWN, OPERATE, OR OWN AND OPERATE A BUSINESS  
8 OTHER THAN A VENDING FACILITY. In authorizing vending facilities OR  
9 OTHER BUSINESSES on state property, the department shall give priority to  
10 persons who are blind and who are licensed by the department in order to  
11 enlarge the economic opportunities of persons who are blind by providing  
12 remunerative employment and to stimulate persons who are blind to  
13 greater efforts in striving to make themselves self-supporting.

14 **SECTION 3.** In Colorado Revised Statutes, **amend as it will**  
15 **become effective July 1, 2016,** 8-84-204 as follows:

16 **8-84-204. Satisfactory sites for vending facilities - other**  
17 **businesses operated by persons who are blind.** (1) (a) A department  
18 or agency of the state of Colorado shall not construct, acquire by  
19 ownership, rent, lease, or other means, or undertake to substantially alter  
20 or renovate, in whole or in part, a building unless, after consultation with  
21 the department of labor and employment, it is determined that the  
22 building will include a satisfactory site or sites for the location and  
23 operation of a vending facility by a person who is blind.

24 (b) BEFORE A STATE DEPARTMENT OR AGENCY CONSTRUCTS,  
25 ACQUIRES, RENTS, LEASES, OR OTHERWISE UNDERTAKES TO ALTER OR  
26 RENOVATE A STATE PROPERTY, THE STATE DEPARTMENT OR AGENCY  
27 SHALL CONSULT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT TO

1 DETERMINE IF THE STATE PROPERTY CAN INCLUDE A SATISFACTORY SITE  
2 FOR THE LOCATION AND OPERATION OF A BUSINESS, OTHER THAN A  
3 VENDING FACILITY, THAT IS OWNED, OPERATED, OR OWNED AND OPERATED  
4 BY A PERSON WHO IS BLIND.

5 (2) Each department or agency shall provide notice to the  
6 department of labor and employment of its plans for the occupation,  
7 acquisition, construction, alteration, or renovation of a building adequate  
8 to permit the department of labor and employment to determine whether  
9 the building includes a satisfactory site for a vending facility OR OTHER  
10 BUSINESS THAT CAN BE OPERATED BY A PERSON WHO IS BLIND AND IS  
11 LICENSED PURSUANT TO SECTION 8-84-203.

12 (3) This section does not apply when the department of labor and  
13 employment determines that the number of people using the building will  
14 be insufficient to support a vending facility OR OTHER BUSINESS.

15 (4) The department of labor and employment shall not be charged  
16 for:

- 17 (a) The use of state-furnished space;
- 18 (b) Maintenance or janitorial services;
- 19 (c) Repair of the building structure in and adjacent to the vending  
20 facility OR OTHER BUSINESS area, including any necessary initial and  
21 periodical painting and decorating;
- 22 (d) Utilities required to operate vending facilities and vending  
23 machines OR EQUIPMENT REQUIRED FOR OTHER BUSINESSES OPERATED BY  
24 PERSONS WHO ARE BLIND; or
- 25 (e) Repairing and replacing floor coverings, cleaning windows, or  
26 providing other related building services in accordance with the normal  
27 level of building service applicable to the state building in which the

1 vending facility OR OTHER BUSINESS is located.

2

3 **SECTION 4.** In Colorado Revised Statutes, **amend as it will**  
4 **become effective July 1, 2016,** 8-84-206 as follows:

5 **8-84-206. Cooperation - locations - rules.** (1) The heads of all  
6 state departments and agencies shall negotiate and cooperate in good faith  
7 to accomplish the purposes of this article relating to vending facilities  
8 AND OTHER BUSINESSES OPERATED BY PERSONS WHO ARE BLIND.

9 (2) If the department of ~~labor and employment~~ determines that the  
10 operation of a vending facility ~~in a~~ OR OTHER BUSINESS ON state ~~building~~  
11 PROPERTY by a person who is blind ~~is not feasible~~ WOULD ADVERSELY  
12 AFFECT THE OPERATIONS OR FUNCTIONS OF THE STATE PROPERTY, the  
13 office of state planning and budgeting may authorize another person to  
14 operate the vending facility OR OTHER BUSINESS.

15 (3) When no person is immediately available on the premises for  
16 the management of vending machines OR OTHER BUSINESSES, the  
17 commission income from the machines shall be given to the department  
18 of ~~labor and employment~~ in accordance with section 8-84-205.

19 (4) The department of ~~labor and employment~~ shall operate a  
20 ~~vending facility~~ THE program AUTHORIZED BY THIS PART 2 in accordance  
21 with its rules and in accordance with federal guidelines under the federal  
22 "Randolph-Sheppard Vending Stand Act", as amended.

23 **SECTION 5.** In Colorado Revised Statutes, **add** 8-84-209 as  
24 follows:

25 **8-84-209. Working group to address expanding opportunities**  
26 **for blind vendors - report - repeal.** (1) (a) THE DEPARTMENT SHALL  
27 CONVENE A WORKING GROUP TO EXAMINE AVENUES FOR EXPANDING JOB

1 AND BUSINESS OPPORTUNITIES AND REDUCING BARRIERS TO THOSE  
2 OPPORTUNITIES FOR PERSONS WHO ARE BLIND AND ARE LICENSED UNDER  
3 SECTION 8-84-203. THE WORKING GROUP SHALL EXAMINE WAYS TO:

4 (I) EXPAND OPPORTUNITIES FOR BLIND VENDORS AT HIGHER  
5 EDUCATION INSTITUTIONS, THE DEPARTMENT OF CORRECTIONS, THE  
6 DEPARTMENT OF NATURAL RESOURCES, AND THE COLORADO STATE FAIR,  
7 INCLUDING REVIEWING BID PROCESSES, SCALING OF OPERATIONS, AND  
8 REVENUE STREAMS THAT WILL RESULT IN ONGOING BUSINESS  
9 DEVELOPMENT AND TRAINING OPPORTUNITIES FOR PERSONS WHO ARE  
10 BLIND; AND

11 (II) LEVERAGE REVENUES FROM BUSINESSES OPERATED BY BLIND  
12 VENDORS AT HIGHER EDUCATION INSTITUTIONS, THE DEPARTMENT OF  
13 CORRECTIONS, THE DEPARTMENT OF NATURAL RESOURCES, AND THE  
14 COLORADO STATE FAIR TO INCREASE AND MODIFY THE ALLOCATION OF  
15 FEDERAL MATCHING DOLLARS UNDER THE FEDERAL  
16 "RANDOLPH-SHEPPARD VENDING STAND ACT", AS AMENDED.

17 (b) ADDITIONALLY, THE WORKING GROUP SHALL CONSIDER WAYS  
18 TO EXPAND THE SCOPE OF THE BUSINESS ENTERPRISE PROGRAM  
19 AUTHORIZED UNDER THIS PART 2 TO TRAIN BLIND VENDORS IN A WIDE  
20 VARIETY OF BUSINESS OPPORTUNITIES BEYOND FOOD SERVICE AND  
21 VENDING FACILITIES.

22 (2) THE DEPARTMENT SHALL HOST THE WORKING GROUP AND  
23 SHALL FACILITATE BROAD PARTICIPATION FROM THE BLIND COMMUNITY,  
24 INCLUDING REPRESENTATIVES OF THE NATIONAL FEDERATION OF THE  
25 BLIND AND THE STATE COMMITTEE OF LICENSED BLIND VENDORS  
26 ESTABLISHED UNDER DEPARTMENT OF HUMAN SERVICES RULES; HIGHER  
27 EDUCATION INSTITUTIONS; THE DEPARTMENT OF CORRECTIONS; THE

1 DEPARTMENT OF NATURAL RESOURCES; THE COLORADO STATE FAIR; AND  
2 OTHER INTERESTED PARTIES AND STATE DEPARTMENTS AND AGENCIES.  
3 THE WORKING GROUP SHALL MEET AS OFTEN AS NECESSARY TO ENABLE IT  
4 TO DEVELOP A REPORT AND RECOMMENDATIONS AS SPECIFIED IN  
5 SUBSECTION (3) OF THIS SECTION.

6 (3) (a) THE WORKING GROUP SHALL DEVELOP AND MAKE  
7 RECOMMENDATIONS, WHICH MAY INCLUDE LEGISLATIVE AND  
8 ADMINISTRATIVE RECOMMENDATIONS, TO:

9 (I) IDENTIFY REMUNERATIVE AND PERMANENT BUSINESS  
10 OPPORTUNITIES:

11 (A) AT HIGHER EDUCATION INSTITUTIONS, THE DEPARTMENT OF  
12 CORRECTIONS, THE COLORADO STATE FAIR, THE DEPARTMENT OF  
13 NATURAL RESOURCES, AND ANY OTHER STATE PROPERTIES IDENTIFIED BY  
14 THE WORKING GROUP; AND

15 (B) IN OTHER TYPES OF BUSINESSES BEYOND FOOD SERVICE AND  
16 VENDING FACILITIES; AND

17 (II) INCREASE AND MODIFY THE ALLOCATION OF FEDERAL  
18 MATCHING DOLLARS UNDER THE FEDERAL "RANDOLPH-SHEPPARD  
19 VENDING STAND ACT", AS AMENDED, TO GENERATE ADDITIONAL  
20 REVENUES FOR INSTITUTIONS OF HIGHER EDUCATION, THE DEPARTMENT OF  
21 CORRECTIONS, THE DEPARTMENT OF NATURAL RESOURCES, THE  
22 COLORADO STATE FAIR, AND OTHER STATE DEPARTMENTS OR AGENCIES  
23 WHERE BLIND VENDORS OPERATE BUSINESSES.

24 (b) RECOMMENDATIONS MAY INCLUDE PREFERENTIAL BID  
25 OPPORTUNITIES FOR LICENSED BLIND VENDORS ON CONTRACTS FOR GOODS  
26 AND SERVICES, OPPORTUNITIES TO OPERATE FOOD SERVICE AND VENDING  
27 FACILITIES, AND A MECHANISM TO COLLECT VENDING INCOME FROM THESE

1 PROPERTIES.

2 (4) THE WORKING GROUP SHALL DEVELOP AND SUBMIT A FINAL  
3 REPORT INCLUDING ITS RECOMMENDATIONS TO THE BUSINESS AFFAIRS AND  
4 LABOR COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND THE  
5 BUSINESS, LABOR, AND TECHNOLOGY COMMITTEE OF THE SENATE, OR  
6 THEIR SUCCESSOR COMMITTEES, BY JANUARY 1, 2017.

7 (5) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2017.

8 **SECTION 6. No appropriation.** The general assembly has  
9 determined that this act can be implemented within existing  
10 appropriations, and therefore no separate appropriation of state moneys  
11 is necessary to carry out the purposes of this act.

12 **SECTION 7. Effective date.** This act takes effect July 1, 2016;  
13 except that section 8-84-209, Colorado Revised Statutes, as enacted in  
14 section 5 of this act, takes effect upon passage.

15 **SECTION 8. Safety clause.** The general assembly hereby finds,  
16 determines, and declares that this act is necessary for the immediate  
17 preservation of the public peace, health, and safety.
