**A BILL FOR AN ACT**

101 **CONCERNING THE ANNUAL DATE BY WHICH THE GENERAL ASSEMBLY**  
102 **RECEIVES A REPORT REGARDING OUTCOMES OF DECISIONS**  
103 **MADE BY THE STATE BOARD OF PAROLE.**

**Bill Summary**

Current law requires the state board of parole and the division of criminal justice in the department of public safety to issue an annual report to the general assembly regarding outcomes of decisions by the state board of parole. The bill changes the annual due date of the report from November 1 to March 31.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 17-22.5-404, **amend**  
3 (6) (e) (I) as follows:

4           **17-22.5-404. Parole guidelines.** (6) (e) (I) **NOTWITHSTANDING**  
5 **SECTION 24-1-136 (11) (a), C.R.S., on or before November 1, 2011, and**  
6 **~~on or before November 1~~ MARCH 31, 2017, AND ON OR BEFORE MARCH**  
7 **31** each year thereafter, the state board of parole and the division of  
8 criminal justice in the department of public safety shall issue a report to  
9 the general assembly regarding outcomes of decisions by the state board  
10 of parole. The data ~~shall~~ **MUST** be reported to the general assembly only  
11 in the aggregate.

12           **SECTION 2. Act subject to petition - effective date.** This act  
13 takes effect at 12:01 a.m. on the day following the expiration of the  
14 ninety-day period after final adjournment of the general assembly (August  
15 10, 2016, if adjournment sine die is on May 11, 2016); except that, if a  
16 referendum petition is filed pursuant to section 1 (3) of article V of the  
17 state constitution against this act or an item, section, or part of this act  
18 within such period, then the act, item, section, or part will not take effect  
19 unless approved by the people at the general election to be held in  
20 November 2016 and, in such case, will take effect on the date of the  
21 official declaration of the vote thereon by the governor.
