Sunset Process - House Business Affairs and Labor Committee. In accordance with the recommendation of the department of regulatory agencies contained in its sunset review, the bill establishes a separate, periodic sunset review for the health care professions profile program, established in the "Michael Skolnik Medical Transparency Act of 2010". The initial sunset review will occur in 2020, with a termination date of September 1, 2021, if the program is not extended.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-34-110, **add** (12)
3 as follows:

4 **24-34-110. Medical transparency act of 2010 - disclosure of**
5 **information about health care licensees - fines - rules - short title -**
6 **legislative declaration - repeal.** (12) THIS SECTION IS REPEALED,
7 EFFECTIVE SEPTEMBER 1, 2021. PRIOR TO THE REPEAL, THE DEPARTMENT
8 OF REGULATORY AGENCIES SHALL REVIEW THE FUNCTIONS OF THE
9 PROGRAM UNDER THIS SECTION AS PROVIDED IN SECTION 24-34-104.

10 **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **add**
11 (52.5) (f) as follows:

12 **24-34-104. General assembly review of regulatory agencies**
13 **and functions for termination, continuation, or reestablishment.**
14 (52.5) The following agencies, functions, or both, terminate on
15 September 1, 2021:

16 (f) THE ADMINISTRATION OF THE "MICHAEL SKOLNIK MEDICAL
17 TRANSPARENCY ACT OF 2010" BY THE DIRECTOR OF THE DIVISION OF
18 PROFESSIONS AND OCCUPATIONS IN ACCORDANCE WITH SECTION
19 24-34-110.

20 **SECTION 3. Act subject to petition - effective date.** This act

1 takes effect at 12:01 a.m. on the day following the expiration of the
2 ninety-day period after final adjournment of the general assembly (August
3 10, 2016, if adjournment sine die is on May 11, 2016); except that, if a
4 referendum petition is filed pursuant to section 1 (3) of article V of the
5 state constitution against this act or an item, section, or part of this act
6 within such period, then the act, item, section, or part will not take effect
7 unless approved by the people at the general election to be held in
8 November 2016 and, in such case, will take effect on the date of the
9 official declaration of the vote thereon by the governor.
