SENATE JOINT RESOLUTION 16-017

101 CONCERNING THE DESIGNATION OF MARCH 16, 2016, AS  
102 AGRICULTURE DAY IN COLORADO.

1 WHEREAS, Americans enjoy the safest, most abundant, and most  
2 affordable food supply in the world, thanks largely to the efficiency and  
3 productivity of America's farm and ranch families; and

4 WHEREAS, As the world's population is predicted to grow from  
5 7 billion to 9 billion by 2045, and the worldwide demand for food will  
6 double by 2050, farmers and ranchers face the challenge of producing  
7 more food, feed, fiber, and fuel; and

8 WHEREAS, Today, 97% of all U.S. farms are family owned, and  
9 each American farmer feeds more than 156 people, a dramatic increase  
10 from the 1960s, when each farmer could feed only 25 people; and

1           WHEREAS, Americans spend less than 9% of their annual income  
2 on food, less than any other developed nation, while American farmers  
3 and ranchers receive on average only 15.8 cents of every dollar spent on  
4 food; and

5           WHEREAS, American farmers and ranchers are the most capable  
6 and responsible providers for the safety, health, and well-being of their  
7 livestock; and

8           WHEREAS, The agriculture industry is the second largest industry  
9 in Colorado, supporting more than 173,000 jobs in Colorado and  
10 contributing \$41 billion to the state's economy; and

11           WHEREAS, Colorado was responsible for exporting more than \$2  
12 billion in food and agricultural products in 2014; and

13           WHEREAS, Colorado agriculture contributes to national security  
14 not only by providing food and fiber, but also by producing energy; and

15           WHEREAS, Colorado recognizes landowners whose livelihood  
16 depends upon the property they reside on, operate on, and care for as they  
17 work to provide basic necessities to all; and

18           WHEREAS, Leadership is vital to the viability of the agriculture  
19 industry, and participants in programs like Future Farmers of America,  
20 4-H, and the Colorado Agricultural Leadership Program help develop  
21 those leadership skills necessary to promote agriculture and educate their  
22 urban cousins on the importance of agriculture to the world; and

23           WHEREAS, Colorado's agriculture industry requires an adequate,  
24 reliable workforce in order to provide food from the field to the table; and

25           WHEREAS, Colorado's farms and ranches provide wildlife  
26 habitat, open space, and a site for innovative and sustainable farming  
27 practices that ensure the protection of state resources; and

28           WHEREAS, Colorado's agricultural producers provide a diverse  
29 and valuable array of livestock and crops, including cattle, dairy, sheep,  
30 hogs, horses, goats, bison, elk, poultry and eggs, and aquaculture; as well  
31 as field corn, sweet corn, wheat, hay, potatoes, barley, sorghum,  
32 sunflowers, dry beans, soybeans, onions, carrots, wine grapes, fruit,

1 numerous other vegetables, honey, and greenhouse and nursery products;  
2 and

3 WHEREAS, Colorado's agriculturists employ sound animal  
4 husbandry practices, ensuring that livestock remain healthy, productive,  
5 and content; and

6 WHEREAS, Colorado agriculture provides an estimated \$67.5  
7 million annually to support the state's wildlife; and

8 WHEREAS, Colorado's farmers and ranchers are innovative  
9 entrepreneurs and business leaders who remain resilient in their  
10 dedication to the continued prosperity of the state's agriculture; and

11 WHEREAS, The protection of private property and the rights of  
12 landowners who provide wholesome, safe food to Americans and others  
13 worldwide is essential; and

14 WHEREAS, Farmers and ranchers are critical to Colorado  
15 agritourism, welcoming tourists from around the world and showing them  
16 all Colorado has to offer; and

17 WHEREAS, Losing agricultural land and water to other uses will  
18 result in overall negative impacts to the state's economy and a loss of food  
19 production vital to all Coloradans; and

20 WHEREAS, March 15, 2016, is "National Agriculture Day"; now,  
21 therefore,

22 *Be It Resolved by the Senate of the Seventieth General Assembly*  
23 *of the State of Colorado, the House of Representatives concurring herein:*

24 That we, the members of the General Assembly, proudly recognize  
25 and designate "Colorado Agriculture Day" on March 16, 2016, in  
26 celebration of the many men and women who strengthen the nation's  
27 agriculture industry; promote a safe, high-quality, and sustainable food  
28 supply; and protect consumers, the environment, and natural resources.

29 *Be It Further Resolved,* That copies of this Joint Resolution be sent  
30 to the Honorable Governor John Hickenlooper, Colorado Commissioner  
31 of Agriculture Don Brown, and the members of the Colorado  
32 congressional delegation.
