**Summary of Legislation**

This bill creates a subcommittee within the Joint Technology Committee (JTC) to address issues related to data privacy and cyber security. Specifically, the subcommittee is required to consider:

- whether state governmental agencies are collecting or retaining data that exceeds what is necessary and appropriate for such agencies to perform their functions;
- who has access to such data, the extent of such access, and appropriate mechanisms to protect sensitive data; and
- additional measures to protect such data against unauthorized access, disclosure, use, modification, or destruction.

The bill specifies that the subcommittee will consist of four legislative members, four members to be appointed by the Governor, and the state's Chief Security Information Officer. The subcommittee is required to meet at least three times per calendar year; communicate with and obtain input from groups throughout the state; and submit its findings and recommendations to the JTC and the General Assembly on or before January 1, 2018. The bill is repealed July 1, 2018.

**State Expenditures**

This bill will increase General Fund costs in the Legislative Department by \$3,392 in FY 2016-17 and FY 2017-18.

**Assumptions.** The fiscal note assumes that the nonlegislative members of the subcommittee will be located in the Denver Metro area and therefore will not incur travel expenses, which could be reimbursed under the bill.

**Legislative Department.** Legislative members of the subcommittee are entitled to per diem and expenses for each legislative meeting they attend. The average rate of per diem and expenses for such a meeting is \$212 per member. The subcommittee will contain four legislative members and the fiscal note assumes it will meet four times per year, for a total annual cost of \$3,392. Legislative agencies will provide staff assistance to the subcommittee, but the increase in workload is expected to be minimal and will be accomplished within existing appropriations.

**Office of Information Technology (OIT).** The bill requires one of the Governor's appointees to the subcommittee to be a representative of OIT. The state's Chief Security Information Officer, who works in OIT, is also required to be a member of the subcommittee. Both of these individuals will attend meetings and potentially work on tasks outside of the meetings, thereby increasing their workload. Additionally, OIT is likely to have data and other information necessary for the subcommittee to accomplish its work. As such, the workload at OIT is expected to increase, although the increase will be minimal and can be accomplished within existing appropriations.

**Other state agencies.** To the extent that state government agencies provide data and input to further the subcommittee's work, workload and costs at those agencies will increase. It is unknown at this time how much assistance will be required; however, the increase is expected to be minimal and can be accomplished within existing appropriations.

## Local Government Impact

To the extent that local government agencies provide data and input to further the subcommittee's work, workload and costs at those agencies will increase. It is unknown at this time how much assistance will be required; however, the increase is expected to be minimal.

## Effective Date

The bill takes effect August 10, 2016, if the General Assembly adjourns on May 11, 2016, as scheduled, and no referendum petition is filed.

## State Appropriations

For FY 2016-17, the Legislative Department requires a General Fund appropriation of \$3,392.
