After consideration on the merits, the Committee recommends the following:

HB16-1335 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 3, line 16, after "**services.**" insert "(1)".

- 2 Page 3, strike lines 18 through 20 and substitute "BUSINESS, VOCATION,
3 OR OCCUPATION, THE PERSON DOES ANY OF THE FOLLOWING WITH RESPECT
4 TO A GOVERNMENT SERVICE OR AN APPOINTMENT TO RECEIVE A
5 GOVERNMENT SERVICE AND IF A GOVERNMENT ENTITY MAKES THE
6 SERVICE OR APPOINTMENT PUBLICLY AVAILABLE WITHOUT CHARGE:
7 (a) THE PERSON RESERVES OR OBTAINS THE SERVICE OR
8 APPOINTMENT, AND THE PERSON SELLS THE SERVICE OR APPOINTMENT;
9 (b) THE PERSON RESERVES OR OBTAINS, WITH THE INTENT TO SELL,
10 THE SERVICE OR APPOINTMENT;
11 (c) THE PERSON RESERVES OR OBTAINS THE SERVICE OR
12 APPOINTMENT, AND THE PERSON APPENDS THE SERVICE OR APPOINTMENT
13 TO ANOTHER GOOD OR SERVICE THE PERSON OFFERS FOR SALE; OR
14 (d) THE PERSON FALSELY REPRESENTS TO THE POTENTIAL
15 CUSTOMER THAT THE PERSON HAS OBTAINED OR SECURED THE SERVICE OR
16 APPOINTMENT, AND THE PERSON ATTEMPTS TO SELL THE SERVICE OR
17 APPOINTMENT.
18 (2) THIS SECTION DOES NOT APPLY WHEN THE PERSON:
19 (a) HAS CONSENT FROM THE GOVERNMENT ENTITY TO SELL THE
20 SPECIFIC SERVICE OR APPOINTMENT OBTAINED OR RESERVED; OR
21 (b) IS OBTAINING AND SELLING OR OFFERING TO SELL ONLY

2 (3) AS USED IN THIS SECTION, "GOVERNMENT ENTITY" MEANS THE
3 STATE OF COLORADO, A POLITICAL SUBDIVISION OF COLORADO, OR AN
4 AGENCY OF EITHER THE STATE OF COLORADO OR A POLITICAL SUBDIVISION
5 OF COLORADO."
