After consideration on the merits, the Committee recommends the following:

HB16-1423 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 5, strike lines 14 through 19 and substitute:
2 "(3) "DESTROY" MEANS TO REMOVE STUDENT PERSONALLY
3 IDENTIFIABLE INFORMATION SO THAT IT IS PERMANENTLY IRRETRIEVABLE
4 IN THE NORMAL COURSE OF BUSINESS."
- 5 Page 8, line 20, before "BY" insert "OR".
- 6 Page 12, line 16, strike "(1) AND (2)" and substitute "(1), (2), AND (3) (b)".
- 7 Page 13, line 27, strike "(1) AND (2)" and substitute "(1), (2), AND (3) (b)".
- 8 Page 16, line 25, strike "INFORMATION." and substitute "INFORMATION
9 AND A COPY OF EACH CONTRACT OR AGREEMENT."
- 10 Page 17, strike lines 23 through 25 and substitute "OF STUDENT
11 PERSONALLY IDENTIFIABLE INFORMATION, THE DEPARTMENT SHALL
12 DETERMINE WHETHER TO TERMINATE".
- 13 Page 18, line 3, after "BREACH," insert "AN OPPORTUNITY FOR THE
14 CONTRACT PROVIDER TO RESPOND CONCERNING THE MATERIAL BREACH,".
- 15 Page 18, line 13, strike "(1) AND (2)" and substitute "(1), (2), AND (3) (b)".
- 16 Page 18, line 17, strike "TERMINATE THE CONTRACT OR AGREEMENT OR".

- 1 Page 19, line 7, strike "(1) OR (2)" and substitute "(1), (2), OR (3) (b)".
2 Page 22, line 7, after "(1)" insert "(a)".
- 3 Page 22, line 9, strike "ABOUT THE TYPES" and substitute "EXPLAINING
4 THE DATA ELEMENTS".
- 5 Page 22, after line 19 insert:
6 "(b) EACH LOCAL EDUCATION PROVIDER SHALL POST AND
7 MAINTAIN ON ITS WEBSITE A LIST OF THE SCHOOL SERVICE CONTRACT
8 PROVIDERS THAT THE LOCAL EDUCATION PROVIDER CONTRACTS WITH AND
9 A COPY OF EACH CONTRACT."
- 10 Page 23, strike lines 1 through 4 and substitute "IDENTIFIABLE
11 INFORMATION, THE LOCAL EDUCATION PROVIDER SHALL DETERMINE".
- 12 Page 23, line 10, after "BREACH," insert "AN OPPORTUNITY FOR THE
13 CONTRACT PROVIDER TO RESPOND CONCERNING THE MATERIAL BREACH,".
- 14 Page 26, line 9, strike "ABOUT THE" and substitute "EXPLAINING THE
15 DATA".
- 16 Page 29, line 26, strike "TERMINATE OR".
