Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB16-069 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend Health and Human Services Committee Report, dated January 28,
- 2 2016, page 1, strike lines 10 through 13 and substitute:
 - 3 "Page 3, line 19, strike "PERFORM," and substitute "PERFORM IN ADDITION
 - 4 TO AN EMERGENCY MEDICAL SERVICE PROVIDER'S SCOPE OF PRACTICE,".
- 5 Amend printed bill, page 3, strike lines 20 through 22.
- 6 Renumber succeeding subparagraphs accordingly.
- 7 Page 3 of the bill, strike lines 26 and 27.
- 8 Page 4 of the bill, strike line 1.
- 9 Renumber succeeding subparagraphs accordingly.
- 10 Page 4 of the bill, line 2, strike "INVENTORY" and substitute
- 11 "COMPLIANCE".
- 12 Page 4 of the bill, strike lines 8 through 10 and substitute "MEDICAL
- 13 SERVICE PROVIDER HAS OBTAINED ADDITIONAL EDUCATION REQUIRED BY
- 14 THE CHIEF MEDICAL OFFICER OR THE CHIEF MEDICAL OFFICER'S DESIGNEE
- 15 AND HAS DEMONSTRATED COMPETENCY VERIFIED BY A PASSING".

- 1 Page 1 of the report, line 15, strike "NATIONALLY".
- 2 Page 2 of the report, after line 15 insert "Page 6 of the bill, line 2, strike
3 "MAY:" and substitute "MAY, WITHIN THE SCOPE OF PRACTICE OF ITS
4 PRACTITIONERS:".
- 5 Page 6 of the bill, after line 4 insert:
- 6 (II) INJURY AND ILLNESS PREVENTION;
7 (III) PATIENT EDUCATION;
8 (IV) RESOURCE NAVIGATION;
9 (V) CARE COORDINATION;
10 (VI) MEDICATION INVENTORY;".
- 11 Renumber succeeding subparagraphs accordingly."
- 12 Page 2 of the report, after line 17 insert "Page 6 of the bill, line 15, strike
13 "SHALL:" and substitute "MAY:.".
- 14 Page 2 of the report, line 21, strike "PROFESSIONAL;". and substitute
15 "PROFESSIONAL;
16 (III) EMERGENCY MEDICAL SERVICE PROVIDER OR PARAMEDIC;".
- 17 Page 2 of the report, after line 26 insert "Page 7 of the bill, after line 2
18 insert:
- 19 "(4) IN DEVELOPING A CARES PROGRAM, AN AUTHORIZED ENTITY
20 MAY EMPLOY ONE OR MORE HEALTH CARE PROFESSIONALS WHO:
21 (a) ARE NOT EMERGENCY MEDICAL SERVICE PROVIDERS; AND
22 (b) WITHIN THEIR SCOPE OF PRACTICE, MAY PROVIDE COMMUNITY
23 HEALTH ASSISTANCE, REFERRALS, AND EDUCATION."
- 24 Renumber succeeding subsection accordingly."
- 25 Page 5 of the report, after line 15 insert "Page 15 of the bill, before line
26 17 insert:
- 27 "SECTION 5. Appropriation. (1) For the 2016-17 state fiscal
28 year, \$112,064 is appropriated to the department of public health and

1 environment. This appropriation is from the general fund. To implement
2 this act, the department may use this appropriation as follows:

3 (a) \$70,184 for use by the health facilities and emergency medical
4 services division for the state EMS coordination, planning and
5 certification program, which amount is based on an assumption that the
6 division will require an additional 1.0 FTE;

7 (b) \$38,080 for the purchase of information technology services;
8 and

9 (c) \$3,800 for the purchase of legal services.

10 (2) For the 2016-17 state fiscal year, \$38,080 is appropriated to
11 the office of the governor for use by the office of information technology.
12 This appropriation is from reappropriated funds received from the
13 department of public health and environment under paragraph (b) of
14 subsection (1) of this section. To implement this act, the office may use
15 this appropriation to provide information technology services for the
16 department of public health and environment.

17 (3) For the 2016-17 state fiscal year, \$3,800 is appropriated to the
18 department of law. This appropriation is from reappropriated funds
19 received from the department of public health and environment under
20 paragraph (c) of subsection (1) of this section. To implement this act, the
21 department of law may use this appropriation to provide legal services for
22 the department of public health and environment."

23 Renumber succeeding section accordingly.

24 Page 1 of the bill, line 102, strike "SERVICES." and substitute "SERVICES,
25 AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION."."
