SB16-208 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation and with a recommendation that it be placed on the consent calendar:

19 IS AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS DESCRIBED IN

2 Page 3, after line 7 insert:
3 "(b) THIS SUBSECTION (4) IS REPEALED, EFFECTIVE JULY 1, 2021."

4 Page 3, line 12, after "(d)" insert "(I)".

5 Page 3, line 16, strike "22-30.5-513." and substitute "22-30.5-513;
6 EXCEPT THAT THIS PARAGRAPH (d) DOES NOT APPLY IF THE CONVERTED
7 SCHOOL IS AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS
8 DESCRIBED IN SECTION 22-54-108 (3) (b) (IV)."

9 Page 3, after line 16 insert:
10 "(II) THIS PARAGRAPH (d) IS REPEALED, EFFECTIVE JULY 1, 2021."

11 Page 3, line 20, after "(a.7)" insert "(I)".

12 Page 3, line 24, strike "ARTICLE." and substitute "ARTICLE; EXCEPT THAT
13 THIS PARAGRAPH (a.7) DOES NOT APPLY IF THE CONVERTED SCHOOL WAS
14 AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS DESCRIBED IN
15 SECTION 22-54-108 (3) (b) (IV), BEFORE THE CONVERSION."

16 Page 3, after line 24 insert:
17 "(II) THIS PARAGRAPH (a.7) IS REPEALED, EFFECTIVE JULY 1,
18 2021."

19 Page 4, line 2, after "(5.5)" insert "(a)".

20 Page 4, line 9, strike "CONVERSION." and substitute "CONVERSION; EXCEPT
21 THAT THIS SUBSECTION (5.5) DOES NOT APPLY IF THE CONVERTED SCHOOL
22 WAS AUTHORIZED BY A SMALL RURAL SCHOOL DISTRICT, AS DESCRIBED IN
23 SECTION 22-54-108 (3) (b) (IV), BEFORE THE CONVERSION."

24 Page 4, after line 9 insert:
25 "(b) THIS SUBSECTION (5.5) IS REPEALED, EFFECTIVE JULY 1,
26 2021."
