1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-47-411, **amend**
3 (9) as follows:

4 **12-47-411. Hotel and restaurant license - definition - rules.**

5 (9) The registered manager for each hotel and restaurant license, ~~or~~ the
6 hotel and restaurant licensee, OR AN EMPLOYEE OR AGENT OF THE HOTEL
7 AND RESTAURANT LICENSEE shall purchase alcohol beverages for one
8 licensed premises only, and the purchases shall be separate and distinct
9 from purchases for any other hotel and restaurant license.

10 **SECTION 2.** In Colorado Revised Statutes, 12-47-412, **amend**
11 (5) as follows:

12 **12-47-412. Tavern license.** (5) The registered manager for each
13 tavern license, ~~or~~ the tavern licensee, OR AN EMPLOYEE OR AGENT OF THE
14 TAVERN LICENSEE shall purchase alcohol beverages for one licensed
15 premises only, and the purchases shall be separate and distinct from
16 purchases for any other tavern license.

17 **SECTION 3.** In Colorado Revised Statutes, 12-47-426, **amend**
18 (4)(b) as follows:

19 **12-47-426. Lodging and entertainment license.** (4) (b) The
20 registered manager for each lodging and entertainment license, ~~or~~ the
21 lodging and entertainment facility licensee, OR AN EMPLOYEE OR AGENT
22 OF THE LODGING AND ENTERTAINMENT FACILITY LICENSEE shall purchase
23 alcohol beverages for one licensed premises only, and the purchases shall
24 be separate and distinct from purchases for any other lodging and
25 entertainment license.

1 **SECTION 4. Act subject to petition - effective date.** This act
2 takes effect at 12:01 a.m. on the day following the expiration of the
3 ninety-day period after final adjournment of the general assembly (August
4 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a
5 referendum petition is filed pursuant to section 1 (3) of article V of the
6 state constitution against this act or an item, section, or part of this act
7 within such period, then the act, item, section, or part will not take effect
8 unless approved by the people at the general election to be held in
9 November 2018 and, in such case, will take effect on the date of the
10 official declaration of the vote thereon by the governor.
