2 **SECTION 1.** In Colorado Revised Statutes, **add** 17-27-101.5 as

2 **17-27-101.5. Purposes of community corrections.** (1) THE  
3 PURPOSE OF THIS ARTICLE 27, WITH RESPECT TO COMMUNITY  
4 CORRECTIONS, IS TO:

5 (a) FURTHER ALL PURPOSES OF SENTENCING AND IMPROVE PUBLIC  
6 SAFETY BY REDUCING THE INCIDENCE OF FUTURE CRIME THROUGH DESIGN  
7 AND IMPLEMENTATION OF RESEARCH-BASED POLICIES, PRACTICES,  
8 PROGRAMS, AND STANDARDS;

9 (b) PREPARE, SELECT, AND ASSIST PEOPLE WHO, AFTER SERVING A  
10 STATUTORILY DEFINED PERIOD OF INCARCERATION, WILL BE TRANSITIONED  
11 AND RETURNED TO THE COMMUNITY THROUGH SUPPORTED PARTNERSHIPS  
12 WITH LOCAL COMMUNITY CORRECTIONS BOARDS;

13 (c) SET INDIVIDUALIZED CONDITIONS OF COMMUNITY  
14 CORRECTIONS SUPERVISION AND PROVIDE SERVICES AND SUPPORT TO  
15 ASSIST PEOPLE IN COMMUNITY CORRECTIONS IN ADDRESSING IDENTIFIED  
16 RISKS AND NEEDS; AND

17 (d) ACHIEVE A SUCCESSFUL DISCHARGE FROM COMMUNITY  
18 CORRECTIONS SUPERVISION THROUGH REDUCTION OF RISKS AND NEEDS  
19 AND SATISFACTORY COMPLIANCE WITH CONDITIONS OF PLACEMENT.

20 **SECTION 2. Act subject to petition - effective date.** This act  
21 takes effect at 12:01 a.m. on the day following the expiration of the  
22 ninety-day period after final adjournment of the general assembly (August  
23 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a  
24 referendum petition is filed pursuant to section 1 (3) of article V of the  
25 state constitution against this act or an item, section, or part of this act  
26 within such period, then the act, item, section, or part will not take effect  
27 unless approved by the people at the general election to be held in

- 1 November 2018 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
