A BILL FOR AN ACT

101 **CONCERNING THE NONSUBSTANTIVE RELOCATION OF LAWS RELATED**
102 **TO PRIVATE OCCUPATIONAL SCHOOLS FROM TITLE 12,**
103 **COLORADO REVISED STATUTES, AS PART OF THE**
104 **ORGANIZATIONAL RECODIFICATION OF TITLE 12.**

Bill Summary

occupations. To implement the initial recommendations of the study:

- ! **Section 1** of the bill creates a new article 64 in title 23 of the Colorado Revised Statutes and relocates the repealed provisions of article 59 of title 12 of the Colorado Revised Statutes to that article 64;
- ! **Sections 2 through 19** of the bill make conforming amendments; and
- ! **Section 20** of the bill repeals article 59 of title 12 of the Colorado Revised Statutes.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add with amended**
3 **and relocated provisions** article 64 to title 23 as follows:

4 **ARTICLE 64**

5 **Private Occupational Schools**

6 **23-64-101. [Formerly 12-59-101] Short title.** ~~This article shall be~~
7 ~~known and may be cited as~~ THE SHORT TITLE OF THIS ARTICLE 64 IS the
8 "Private Occupational Education Act of 1981".

9 **23-64-102. [Formerly 12-59-102] Legislative declaration.** (1) It
10 is the purpose of this ~~article~~ ARTICLE 64 to provide standards for and to
11 foster and improve private occupational schools and their educational
12 services and to protect the citizens of this state against fraudulent or
13 substandard private occupational schools by:

14 (a) Prohibiting the use of false or misleading literature,
15 advertising, or representations by private occupational schools or their
16 agents;

17 (b) Establishing accountability for private occupational schools
18 and their agents through the setting of standards relative to the quality of
19 educational services, fiscal responsibility, and ethical business practices;

20 (c) Providing for the preservation of essential records;

1 (d) Providing certain rights and remedies to the private
2 occupational school division, the private occupational school board
3 created in ~~section 12-59-105.~~ SECTION 23-64-107, and the consuming
4 public necessary to effectuate the purposes of this ~~article~~ ARTICLE 64;

5 (e) Providing for the authorization of appropriate educational
6 credentials by approved schools, including, but not limited to, certificates,
7 diplomas, and associate degrees; and

8 (f) Providing train-out for students of private occupational schools
9 ceasing operation.

10 (2) To these ends, this article shall be liberally construed.

11 **23-64-103. [Formerly 12-59-103] Definitions.** As used in this

13 (1) "Administrative law judge" means a person, appointed by the
14 authority from a list provided by the attorney general, who shall conduct
15 hearings on any matter ~~which~~ THAT is within the jurisdiction of the
16 division and ~~which~~ THAT is referred to ~~such~~ THE administrative law judge
17 by the division.

18 ~~(1.5)~~ (2) "Agent" means any person owning any interest in,
19 employed by, or representing for remuneration or other consideration a
20 private occupational school located within or without this state who
21 enrolls or who, in places other than the principal school premises, offers
22 or attempts to secure the enrollment of any person within this state for
23 education in a school.

24 ~~(2)~~ (3) "Agent's permit" means a nontransferable written
25 authorization issued to an agent pursuant to the provisions of this ~~article~~
26 ARTICLE 64 by the division upon approval by the executive director.

27 ~~(2.5)~~ (4) "Associate degree" means a degree offered by a school

1 on the successful completion of the degree requirements as established by
2 the division.

3 ~~(2.6)~~ (5) "Board" means the private occupational school board
4 created in ~~section 12-59-105.†~~ SECTION 23-64-107.

5 ~~(2.7)~~ (6) "Ceasing operation" means the voluntary discontinuation
6 of operation by a private occupational school or the discontinuation of
7 operation by a private occupational school due to the denial, expiration,
8 revocation, or suspension of ~~such~~ THE school's certificate of approval by
9 the division.

10 ~~(2.8)~~ (7) "Certificate" means an award for the successful
11 completion of a specific course or program objective.

12 ~~(3)~~ (8) "Certificate of approval" means a written authorization
13 issued by the division, upon approval by the executive director, to the
14 principal owners of a school in the name of ~~such~~ THE school, pursuant to
15 the provisions of this ~~article~~ ARTICLE 64, to operate a school in this state.

16 ~~(3.5)~~ (9) "Diploma" means an award for the successful completion
17 of an approved prescribed program of study in a particular field of
18 endeavor.

19 ~~(3.6)~~ (10) "Director" means the director of the private
20 occupational school division created pursuant to ~~section 12-59-104.†~~
21 SECTION 23-64-105.

22 ~~(3.7)~~ (11) "Division" means the private occupational school
23 division created pursuant to ~~section 12-59-104.†~~ SECTION 23-64-105.

24 ~~(4)~~ (12) "Educational credentials" means certificates, diplomas,
25 associate degrees, transcripts, reports, numbers, or words ~~which~~ THAT
26 signify or are generally taken to signify enrollment, attendance, progress,
27 or satisfactory completion of the requirements for education at a school.

1 ~~(5)~~ (13) "Educational services" or "education" includes, but is not
2 limited to, any class, course, or program of training, instruction, or study
3 ~~which~~ THAT is designed or is purported to meet all or part of the
4 requirements for employment in an agricultural, trade, industrial,
5 technical, business, office, sales, service, or health occupation and ~~which~~
6 constitutes occupational education.

7 ~~(6)~~ (14) "Entity" includes, but is not limited to, any person,
8 society, association, partnership, corporation, or trust.

9 ~~(7)~~ (15) "Executive director" means the executive director of the
10 department of higher education appointed pursuant to section 23-1-110
11 (2). ~~C.R.S.~~

12 ~~(8)~~ (16) "New school" means a private occupational school that
13 does not hold an existing certificate of approval as of June 30, 1981, or
14 a school holding an existing certificate of approval as of June 30, 1981,
15 ~~which~~ THAT subsequently expires pursuant to the provisions of ~~section~~
16 ~~12-59-108 (4)~~ SECTION 23-64-114 (4) or is revoked or denied pursuant to
17 the provisions of this ~~article~~ ARTICLE 64.

18 ~~(8.5)~~ (17) "Occupational education" means any education
19 designed to facilitate the vocational, technical, or occupational
20 development of individual persons, including, but not limited to,
21 vocational or technical training or retraining ~~which~~ THAT is given in
22 schools or classes, including field or laboratory work incident thereto,
23 ~~which~~ THAT is conducted as a part of a program designed to fit
24 individuals for gainful employment as semiskilled or skilled workers or
25 technicians in recognized occupations requiring less than a four-year
26 baccalaureate degree. The term also includes instruction related to the
27 occupation for which the person is being trained or ~~which~~ THAT is

1 necessary for him OR HER to benefit from ~~such~~ THE training.

2 ~~(9)~~ (18) "Offer" or "offering" includes, in addition to its usual
3 meaning, advertising, publicizing, soliciting, or encouraging any person
4 in any manner to perform the act described.

5 ~~(10)~~ (19) "Operate" or "operating", when used with respect to a
6 school, means to establish, keep, or maintain any facility or location in
7 this state where, from, or through which educational services are offered
8 or educational credentials are offered or granted.

9 ~~(11)~~ (20) "Private occupational school" or "school" means any
10 entity or institution for profit or not for profit located within or without
11 this state ~~which~~ THAT offers educational credentials or educational
12 services that constitute occupational education in this state and ~~which~~
13 THAT is not specifically exempt from the provisions of this ~~article~~
14 ARTICLE 64.

16 ~~(13)~~ (21) "Train-out" means the opportunity for a student of a
17 private occupational school ceasing operation to meet ~~such~~ THE student's
18 educational objectives through training provided by another approved
19 private occupational school, a community college, an area technical

21 **23-64-104. [Formerly 12-59-104] Exemptions.** (1) The
22 following educational institutions and educational services are exempt
23 from the provisions of this ~~article~~ ARTICLE 64:

24 (a) A public school or public educational institution funded
25 wholly or in part by a local school district or school districts or by direct
26 appropriation from the state to a school, public educational institution, or
27 board;

3 from general property taxation under the laws of this state;

4 (c) A school offering education solely avocational, supplementary,

7 (I) Confers four-year baccalaureate or higher degrees; and

8 (II) Offers programs or courses in this state, the majority of which
9 are not occupational in nature, as defined by the division, or are at the
10 graduate level;

13 comparable to that provided in public elementary and secondary schools
14 of this state;

18 for the training of its employees;

19 ~~(i)~~ (h) Education offered by a bona fide trade, business,
20 professional, or fraternal organization that primarily benefits the
21 organization's membership or mission;

22 ~~(j)~~ (i) Educational services offered by an employer for the training
23 of its own employees;

24 ~~(k)~~ (j) Apprenticeship training registered pursuant to state or
25 federal law;

26 ~~(l)~~ (k) Educational services offered by an approved school ~~which~~
27 THAT:

1 (I) Do not require the payment of money or other consideration;

2 (II) Are avocational, supplementary, or ancillary in nature; or

3 (III) Are offered only to an employer for the training and
4 preparation of his OR HER employees;

6 12-38.1-108 (1);

7 ~~(n)~~ (m) Flight schools that are approved and regulated by the
8 federal aviation administration;

12 ~~(q)~~ (n) A private educational institution that is accredited by an
13 agency recognized by the United States department of education, that
14 confers post-graduate degrees, and that offers programs or courses that
15 are not defined as occupational education pursuant to ~~section 12-59-103~~
16 ~~(8.5)~~ SECTION 23-64-103 (17);

17 ~~(r)~~ (o) A continuing professional education program that meets the
18 requirements for maintaining or renewing a professional license issued by
19 a Colorado state professional licensing entity so long as the continuing
20 professional education program or the organization that provides the
21 program is approved by the Colorado state professional licensing entity
22 either before or after a licensee attends the program. To qualify for the
23 exemption created in this ~~paragraph (r)~~ SUBSECTION (1)(o), a continuing
24 professional education program must be consistent with the purposes or
25 requirements of the organization that provides the program.

27 **23-64-105. [Formerly 12-59-104.1] Private occupational school**

1 **division - creation.** There is hereby created the private occupational
2 school division in the department of higher education and the office of
3 director of the division. The division and the director shall exercise their
4 powers and perform their duties and functions specified in this ~~article~~
5 ARTICLE 64 under the department of higher education and the executive
6 director thereof as if the same were transferred to the department by a
7 **type 2** transfer as such transfer is defined in the "Administrative
8 Organization Act of 1968", article 1 of title 24. ~~C.R.S.~~ The director shall
9 be appointed by the executive director. The director, with the approval of
10 the executive director, shall employ such professional and clerical
11 personnel as deemed necessary to carry out the duties and function of the
12 division. The director and professional personnel are declared to hold
13 educational offices and to be exempt from the state personnel system.

4 nothing contained in any such reciprocity agreement shall be construed
5 as limiting the division's powers, duties, and responsibilities with respect
6 to investigating or acting upon any application for a certificate of
7 approval for a private occupational school or an application for issuance
8 of or renewal of any agent's permit or with respect to the enforcement of
9 any provision of this ~~article~~ ARTICLE 64 or any of the rules promulgated
10 under this ~~article~~ ARTICLE 64.

13 **23-64-107. [Formerly 12-59-105.1] Private occupational school**
14 **board - established - membership.** (1) Effective June 30, 1998, the
15 private occupational school policy advisory committee is abolished, and
16 the terms of members of the advisory committee serving as such
17 immediately prior to June 30, 1998, are terminated.

18 (2) Effective July 1, 1998, there is established, in the private
19 occupational school division, the private occupational school board that
20 shall advise the director on the administration of this ~~article~~ ARTICLE 64
21 and shall have the powers and duties specified in ~~section 12-59-105.3~~
22 SECTION 23-64-108. The board shall exercise its powers and perform its
23 duties and functions specified in this ~~article~~ ARTICLE 64 as if the same
24 were transferred to the department of higher education by a **type 1**

6 Colorado and is familiar with federal loans and funds authorized in Title
7 IV of the federal "Higher Education Act of 1965", as amended, and at
8 least two of whom are owners or operators of businesses within Colorado
9 that employ students who are enrolled in schools that are subject to
10 administration by the division.

11 (4) No appointed member shall be an employee of any junior
12 college, community or technical college, school district, or public agency
13 that receives vocational funds allocated by any state agency.

14 (5) (a) The board members shall serve four-year terms; except
15 that, of the members first appointed to the board, three members to be
16 selected by the governor shall serve two-year terms. A member shall not
17 serve more than two consecutive four-year terms.

18 (b) Notwithstanding the provisions of ~~paragraph (a) of this~~
19 ~~subsection (5)~~ SUBSECTION (5)(a) OF THIS SECTION, of the three members
20 appointed to replace persons whose terms expire on June 30, 2012, one

24 appointments to the positions identified in this ~~paragraph (b)~~ SUBSECTION

2 member selected by the governor shall serve a one-year term, one

5 member selected by the governor shall serve a four-year term. Subsequent
6 appointments to the positions identified in this ~~paragraph (c)~~ SUBSECTION

8 (6) The board shall hold regular meetings at such times as it may
9 deem appropriate, but it shall not meet less than four times per year.

10 (7) Board members shall be paid a per diem of thirty-five dollars
11 for each day on which the board meets and their actual and necessary
12 expenses incurred in the conduct of official business.

13 (8) The division shall provide any necessary staff assistance for
14 the board.

16 **- rules.** (1) The board shall have the following powers and duties:

13 books, records, or documents pertaining to ~~such~~ THE investigation; to
14 require answers in writing, under oath, to questions propounded by the
15 board; and to administer an oath or affirmation to any person in
16 connection with any such investigation. ~~Such~~ THE investigation may
17 include the physical inspection of school facilities and records. ~~Said~~ THE
18 subpoena shall be enforceable by any court of record of this state.

22 (h) To appoint administrative law judges to conduct hearings on

25 ~~paragraph (f) of this subsection (1)~~ SUBSECTION (1)(f) OF THIS SECTION;

1 appropriate for the conduct of its work and the implementation of this

4 awarding of appropriate educational credentials by private occupational
5 schools;

6 ~~(h)~~ (k) To exercise other powers and duties implied, but not

8 necessary in order to carry out the provisions of this ~~article~~ ARTICLE 64;

9 ~~(m)~~ (l) To designate, by category of instruction, those schools that
10 teach students under sixteen years of age for which instructional staff and
11 prospective instructional staff, as defined by board rule, shall be required
12 to submit a complete set of fingerprints pursuant to ~~section 12-59-105.7~~
13 SECTION 23-64-110;

14 ~~(n)~~ (m) To prescribe uniform academic reporting policies and
15 procedures to which a private occupational school shall adhere.

16 **23-64-109. [Formerly 12-59-105.4] Duties of private**
17 **occupational schools.** A private occupational school shall provide the
18 division with such data as the board deems necessary upon written request
19 of the board. Data pertaining to individual students or personnel shall not
20 be divulged or made known in any way by a member of the board, by the
21 director, or by any division or school employee, except in accordance
22 with judicial order or as otherwise provided by law. A person who
23 violates this section commits a class 1 misdemeanor and shall be punished
24 as provided in section 18-1.3-501. ~~C.R.S.~~ In addition, ~~such~~ THE person
25 shall be subject to removal or dismissal from public service on grounds
26 of malfeasance in office.

27 **23-64-110. [Formerly 12-59-105.7] Submittal of fingerprints**

1 **for persons teaching at designated schools - fingerprint-based**
2 **criminal history record checks - prerequisite for commencing or**
3 **continuing employment.** (1) (a) Instructional staff or prospective

4 instructional staff who may be teaching students in a school designated
5 by the board pursuant to ~~section 12-59-105.3 (1) (m)~~ SECTION 23-64-108
6 (1)(l) shall, beginning July 1, 2006, in order to commence or continue
7 employment at a designated school, submit a set of his or her fingerprints
8 to the Colorado bureau of investigation for the purpose of conducting a
9 state and national fingerprint-based criminal history record check utilizing
10 records of the Colorado bureau of investigation and the federal bureau of
11 investigation. Nothing in this section shall preclude the board from
12 making further inquiries into the background of instructional staff or
13 prospective instructional staff. Instructional staff or prospective
14 instructional staff shall pay the fee established by the Colorado bureau of
15 investigation for conducting the fingerprint-based criminal history record
16 check. Upon completion of the criminal history record check, the bureau
17 shall forward the results to the board. The board shall conduct a review
18 of the results of the criminal history record check forwarded by the
19 bureau and consider the results in assessing whether instructional staff or
20 prospective instructional staff meet minimum standards of qualification,
21 as established by the board pursuant to ~~section 12-59-106~~ SECTION
22 23-64-112, necessary to commence or continue employment at the
23 designated school.

24 (b) Instructional staff or prospective instructional staff shall be
25 required to resubmit a set of his or her fingerprints pursuant to ~~paragraph~~
26 ~~(a) of this subsection (1)~~ SUBSECTION (1)(a) OF THIS SECTION even if he
27 or she previously submitted his or her fingerprints pursuant to ~~paragraph~~

1 ~~(a) of this subsection (1)~~ SUBSECTION (1)(a) OF THIS SECTION.

2 (2) In addition to any other requirements established by the board
3 for the necessary qualifications of instructional staff or prospective
4 instructional staff, the submittal of fingerprints pursuant to subsection (1)
5 of this section and results consistent with the minimum standards of
6 qualification established by the board pursuant to ~~section 12-59-106~~
7 SECTION 23-64-112 shall be a prerequisite to commencing or continuing
8 employment as instructional staff who may be teaching students in a
9 school designated by the board pursuant to ~~section 12-59-105.3 (1) (m)~~
10 SECTION 23-64-108 (1)(l).

11 **23-64-111. [Formerly 12-59-105.9] Duties and powers of the**
12 **division subject to approval of the executive director.** The division
13 shall exercise all of the powers and duties set forth in ~~section 12-59-105~~
14 SECTION 23-64-106. The executive director shall review and approve,
15 consistent with the institutional role and statewide needs, any action taken
16 by the division pursuant to the powers and duties set forth in ~~section~~
17 ~~12-59-105~~ SECTION 23-64-106; except that the participation of the
18 executive director shall not be required in any action taken by the board.

19 **23-64-112. [Formerly 12-59-106] Minimum standards.** (1) In
