she is registered with the state board of chiropractic examiners to perform animal chiropractic, must obtain a veterinary medical clearance from a licensed veterinarian before performing an act that falls within the chiropractor's scope of practice on an animal patient. The bill removes the veterinary medical clearance requirement for chiropractors who are registered with the state board as animal chiropractors. A licensed chiropractor who is registered as an animal chiropractor and performs animal chiropractic on an animal patient is encouraged to consult with a veterinarian treating the animal patient.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-33-127, **amend**
3 (1)(a), (6)(a), (6)(b), and (6)(c) as follows:

4 **12-33-127. Animal chiropractic - registration - qualifications**
5 **- continuing education - collaboration with veterinarian - discipline**
6 **- title restriction - rules.** (1) (a) A licensed chiropractor who is
7 registered under this section ~~is authorized to~~ MAY perform animal
8 chiropractic when ~~such~~ THE chiropractic diagnosis and treatment is
9 consistent with the scope of practice for chiropractors. ~~and the animal has~~
10 ~~been provided a veterinary medical clearance by a licensed veterinarian.~~
11 A chiropractor ~~shall~~ MUST have the knowledge, skill, ability, and
12 documented competency to perform an act that is within the scope of
13 practice for chiropractors.

14 **(6) Records and professional collaboration.** (a) A licensed
15 veterinarian who provides veterinary medical clearance for ~~animal~~
16 ~~chiropractic~~ A CHIROPRACTOR WHO IS NOT REGISTERED AS AN ANIMAL
17 CHIROPRACTOR PURSUANT TO SUBSECTION (1)(a) OF THIS SECTION may
18 require a veterinarian's presence at any chiropractic treatment rendered BY
19 THE CHIROPRACTOR pursuant to the veterinary medical clearance
20 REQUIRED BY SUBSECTION (1)(c) OF THIS SECTION.

1 (b) (I) IF AN ANIMAL CHIROPRACTOR REGISTERED PURSUANT TO
2 SUBSECTION (1)(a) OF THIS SECTION IS DIAGNOSING AND TREATING AN
3 ANIMAL PATIENT THAT IS ALSO UNDER THE CARE OF A LICENSED
4 VETERINARIAN, the chiropractor ~~and~~ IS ENCOURAGED, IN A TIMELY
5 MANNER, TO CONSULT WITH the veterinarian, ~~shall continue professional~~
6 ~~collaboration~~ AND THE CHIROPRACTOR AND VETERINARIAN ARE
7 ENCOURAGED TO COLLABORATE as necessary for the well-being of the
8 animal patient. The veterinarian shall provide the animal patient's medical
9 record to the chiropractor upon request.

10 (II) IF A CHIROPRACTOR WHO IS NOT REGISTERED PURSUANT TO
11 SUBSECTION (1)(a) OF THIS SECTION IS DIAGNOSING AND TREATING AN
12 ANIMAL PATIENT, THE CHIROPRACTOR SHALL MAINTAIN PROFESSIONAL
13 COLLABORATION WITH THE VETERINARIAN WHO PROVIDED VETERINARY
14 MEDICAL CLEARANCE AS NECESSARY FOR THE WELL-BEING OF THE ANIMAL
15 PATIENT. THE VETERINARIAN SHALL PROVIDE THE ANIMAL PATIENT'S
16 MEDICAL RECORD TO THE CHIROPRACTOR UPON REQUEST.

17 (c) ~~The~~ A chiropractor, WHETHER OR NOT HE OR SHE IS A
18 REGISTERED ANIMAL CHIROPRACTOR, shall maintain an animal patient
19 record. ~~that includes the written veterinary medical clearance, including~~
20 ~~the name of the veterinarian, date, and time the clearance was received.~~
21 The chiropractor shall furnish a copy of the medical record to ~~the~~ A
22 veterinarian WHO IS TREATING THE ANIMAL PATIENT upon the
23 veterinarian's request.

24 **SECTION 2. Act subject to petition - effective date.** This act
25 takes effect at 12:01 a.m. on the day following the expiration of the
26 ninety-day period after final adjournment of the general assembly (August
27 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a

1 referendum petition is filed pursuant to section 1 (3) of article V of the
2 state constitution against this act or an item, section, or part of this act
3 within such period, then the act, item, section, or part will not take effect
4 unless approved by the people at the general election to be held in
5 November 2018 and, in such case, will take effect on the date of the
6 official declaration of the vote thereon by the governor.
