11 12 13 14	WHEREAS, The state of Colorado is honored to be the home of NORAD, as well as the home of the United States and Canadian service members and their families that work and live in the Centennial State; now, therefore,
15 16	Be It Resolved by the House of Representatives of the Seventy-first General Assembly of the State of Colorado, the Senate concurring herein:
17 18	That we, the members of the Seventy-first General Assembly, hereby:
19 20	(1) Join our Canadian friends and allies in celebration of the one hundred-fiftieth anniversary of Canada's autonomy;
