1                    WHEREAS, Nearly half of all Colorado hospitals are in rural  
2                    areas; and

3                    WHEREAS, Vulnerable rural communities depend upon their rural  
4                    hospital as an important and often the only source of health care services;

6                    WHEREAS, Rural hospitals often face workforce shortages,  
7                    volatile economic conditions, and changing demographics; and

8                    WHEREAS, Rural hospitals are typically smaller and have fewer

1 patients and resources, but still provide a broad range of services to meet  
2 the needs of their communities; and

3 WHEREAS, Many rural Colorado hospitals face unsustainable and  
4 uncertain futures as a result of recent budget cuts, leaving their  
5 communities at risk for losing access to vital health care services; and

6 WHEREAS, 17 of Colorado's 64 counties have no hospitals; and

7 WHEREAS, Rural hospitals not only provide crucial health care  
8 services to their communities but also play a significant role in local  
9 economies, generating \$2.28 in economic activity for every \$1 spent; and

10 WHEREAS, Viable options are needed if Colorado's rural  
11 communities are going to maintain access to the health care services they  
12 need in the long term; now, therefore,

13 *Be It Resolved by the House of Representatives of the Seventy-first*  
14 *General Assembly of the State of Colorado, the Senate concurring herein:*

15 That we, the members of the Colorado General Assembly:

16 (1) Express our appreciation and gratitude to all those Coloradans  
17 who dedicate their time and energy to providing access to health care  
18 services in rural communities;

19 (2) Recognize the importance of protecting rural hospitals and  
20 health care; and

21 (3) Declare March 8, 2017, to be "Protecting Rural Hospitals Day"  
22 in Colorado.
