BILL TOPIC: DOMESTIC VIOLENCE AWARENESS BARBERS COSMETOLOGISTS

NOTE: This bill was not enacted into law; therefore, the impacts identified in this analysis do not take effect.

Summary of Legislation

The bill requires barbers, hairstylists, cosmetologists, estheticians, and nail technicians to obtain one hour of domestic violence and sexual assault awareness training to qualify for the first renewal or reinstatement of a license after June 30, 2018. The bill does not subject these professions to mandatory reporting requirements. The director of the Division of Professions and Occupations in the Department of Regulatory Agencies (DORA) must designate the training provider and may contract with a third-party to provide the training. The director must also determine other rules and training standards as outlined in the bill, and consult with one or more statewide organizations serving victims of domestic violence or sexual assault during the rulemaking process.

Background

As of January 2017, there are approximately 57,000 professionals registered under the Barbers and Cosmetologists Act.

State Expenditures

Beginning in FY 2017-18, the bill will minimally increase workload in the Division of Professions and Occupations in DORA. Beginning in FY 2018-19, the bill may increase workload in the Judicial Department.

Assumptions. The fiscal note assumes that the training course will be paid for by licensees, and that licensees will submit an attestation that they have completed the training program to DORA at the time of renewal or reinstatement.

Department of Regulatory Agencies. In FY 2017-18, the director of the Division of Professions and Occupations will experience a minimal workload increase to designate a contractor, which can be accomplished within existing appropriations.

Judicial Department. Beginning FY 2018-19, to the extent that more domestic violence and assault cases are reported and filed as a result of the training, workload in the trial courts of the Judicial Department will increase. This minimal increase can be accomplished within existing appropriations.

Effective Date

The bill was postponed indefinitely by the Senate State, Veterans, and Military Affairs Committee on April 12, 2017.
