After consideration on the merits, the Committee recommends the following:

HB17-1370 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 6, line 6, before "TWO" insert "AT LEAST".
- 2 Page 9, line 8, strike "licensed" and substitute "~~licensed~~ THAT APPLIED
3 FOR A LICENSE".
- 4 Page 9, line 9, strike "APRIL 1," and substitute "APRIL 30,".
- 5 Page 9, line 27, strike "LICENSED" and substitute "THAT APPLIED FOR A
6 LICENSE".
- 7 Page 10, line 1, strike "1," and substitute "30,".
- 8 Page 11 of the bill, line 8, after "(4)(a)," insert "and", and strike "portion,
9 (4)(b)(IV)(C), and" and substitute "portion;".
- 10 Page 11, line 9, strike "(4)(b)(IV)(D);", and strike "(4)(c)" and substitute
11 "(4)(b)(V), (4)(c), and (4)(d)".
- 12 Page 11 of the bill, line 17, after "2016," insert "AND THAT APPLIED TO
13 CONVERT ITS RETAIL LIQUOR LICENSE TO A LIQUOR-LICENSED DRUGSTORE
14 LICENSE ON OR BEFORE MAY 1, 2017,".
- 15 Page 11, line 19, strike "~~at least~~" and substitute "at least".

1 Page 12 of the bill, strike lines 15 and 16 and substitute "1, 2016, OR A
2 RETAIL LIQUOR STORE LICENSEE THAT WAS LICENSED AS A
3 LIQUOR-LICENSED DRUGSTORE ON FEBRUARY 21, 2016, AND THAT
4 APPLIED, ON OR BEFORE MAY 1, 2017, TO CONVERT ITS RETAIL LIQUOR
5 LICENSE TO A LIQUOR-LICENSED DRUGSTORE LICENSE,".

6 Page 12, strike lines 20 through 27 and substitute:

7 "(V) FOR A PERSON THAT SUBMITTED AN APPLICATION FOR A NEW
8 LIQUOR-LICENSED DRUGSTORE LICENSE ON OR BEFORE OCTOBER 1, 2016,
9 ADDITIONAL LIQUOR-LICENSED DRUGSTORE LICENSES AS FOLLOWS, BUT
10 ONLY IF OBTAINED IN ACCORDANCE WITH SUBSECTION (1)(b) OF THIS
11 SECTION:

12 (A) ON OR AFTER JULY 1, 2017, AND BEFORE JANUARY 1, 2022,
13 FOUR ADDITIONAL LIQUOR-LICENSED DRUGSTORE LICENSES, FOR A
14 MAXIMUM OF FIVE TOTAL LIQUOR-LICENSED DRUGSTORE LICENSES;

15 (B) ON OR AFTER JANUARY 1, 2022, AND BEFORE JANUARY 1,
16 2027, UP TO SEVEN ADDITIONAL LIQUOR-LICENSED DRUGSTORE LICENSES,
17 FOR A MAXIMUM OF EIGHT TOTAL LIQUOR-LICENSED DRUGSTORE
18 LICENSES;

19 (C) ON OR AFTER JANUARY 1, 2027, AND BEFORE JANUARY 1,
20 2032, UP TO TWELVE ADDITIONAL LIQUOR-LICENSED DRUGSTORE
21 LICENSES, FOR A MAXIMUM OF THIRTEEN TOTAL LIQUOR-LICENSED
22 DRUGSTORE LICENSES; AND

23 (D) ON OR AFTER JANUARY 1, 2032, AND BEFORE JANUARY 1,
24 2037, UP TO NINETEEN ADDITIONAL LIQUOR-LICENSED DRUGSTORE
25 LICENSES, FOR A MAXIMUM OF TWENTY TOTAL LIQUOR-LICENSED
26 DRUGSTORE LICENSES."

27 Page 13, line 6, strike "(4)(b)(IV)" and substitute "(4)(b)(V)".

28 Page 13, line 11, strike "(4)(b)(IV)." and substitute "(4)(b)(V).".

29 Page 13 of the bill, after line 11 insert:

30 "(d) SUBSECTION (4)(b)(V) OF THIS SECTION DOES NOT APPLY TO
31 A RETAIL LIQUOR STORE LICENSEE THAT WAS LICENSED AS A
32 LIQUOR-LICENSED DRUGSTORE ON FEBRUARY 21, 2016, AND THAT
33 APPLIED, ON OR BEFORE MAY 1, 2017, TO CONVERT ITS RETAIL LIQUOR
34 LICENSE TO A LIQUOR-LICENSED DRUGSTORE LICENSE."
