### A BILL FOR AN ACT

101 CONCERNING ALLOWING COMMUNITY COLLEGES TO OFFER A
102 BACHELOR OF SCIENCE DEGREE IN NURSING.

### **Bill Summary**

The bill allows a community college that is part of the state system of community and technical colleges to offer a bachelor of science degree in nursing.
