**Bill Summary**

**Joint Budget Committee.** The bill authorizes the broadband deployment board to apply for federal funding of broadband deployment and allocate any federal money received to broadband deployment projects approved by the board. The bill also directs the board to petition the federal communications commission (FCC) for a waiver from the

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 40-15-509.5, **add**  
3 (10.5) as follows:

4 **40-15-509.5. Broadband service - report - broadband**  
5 **deployment board - broadband administrative fund - creation -**  
6 **definitions - repeal.** (10.5) (a) THE BOARD MAY APPLY FOR FEDERAL

7 FUNDING OF BROADBAND DEPLOYMENT PROJECTS AND PROGRAMS. THE  
8 HCSM THIRD-PARTY CONTRACTOR SHALL MAINTAIN ANY FEDERAL  
9 MONEY AWARDED FOR BROADBAND DEPLOYMENT IN A SEPARATE  
10 ACCOUNT OF THE HCSM THAT IS DEDICATED TO ALLOCATING FEDERAL  
11 BROADBAND DEPLOYMENT MONEY. THE COMMISSION IS AUTHORIZED TO  
12 DISBURSE ANY MONEY FROM THE ACCOUNT AS DIRECTED BY THE BOARD.

13 (b) (I) FOLLOWING THE MODEL OF NEW YORK'S PETITION FOR  
14 EXPEDITED WAIVER, THE BOARD SHALL IMMEDIATELY PETITION THE FCC  
15 FOR A WAIVER FROM THE AUCTION RULES THAT PROHIBIT A STATE ENTITY  
16 FROM APPLYING FOR CONNECT AMERICA FUND PHASE II AUCTION MONEY  
17 TO ALLOW THE BOARD ITSELF TO ALLOCATE AUCTION MONEY FOR  
18 BROADBAND DEPLOYMENT PROJECTS APPROVED BY THE BOARD.

19 (II) AFTER SUBMITTING THE PETITION TO THE FCC, THE BOARD  
20 MAY:

21 (A) FILE ANY ADDITIONAL DOCUMENTATION THAT THE FCC  
22 REQUIRES OF THE BOARD IN CONSIDERING THE BOARD'S PETITION; AND

23 (B) COORDINATE WITH THE FCC TO DEVELOP ANY CONDITIONS

1 THAT THE FCC MIGHT REQUIRE TO GRANT THE PETITION.

2 (III) IF THE FCC GRANTS THE BOARD'S PETITION AND AWARDS THE  
3 BOARD AUCTION MONEY:

4 (A) THE HCSM THIRD-PARTY CONTRACTOR SHALL MAINTAIN ANY  
5 FEDERAL MONEY AWARDED FROM THE AUCTION IN THE SEPARATE  
6 ACCOUNT OF THE HCSM DESCRIBED IN SUBSECTION (10.5)(a) OF THIS  
7 SECTION; AND

8 (B) THE COMMISSION IS AUTHORIZED TO DISBURSE THE FEDERAL  
9 MONEY IN THAT ACCOUNT FOR BROADBAND DEPLOYMENT GRANTS AS  
10 DIRECTED BY THE BOARD.

11 (IV) THE BOARD MAY COORDINATE WITH THE FCC TO COMPLY  
12 WITH ANY CONDITIONS ESTABLISHED BY THE FCC IN GRANTING THE  
13 PETITION. IF ANY SUCH FCC CONDITIONS IMPOSE PROJECT ELIGIBILITY,  
14 APPLICATION PROCESS, AWARD CRITERIA, OR OTHER REQUIREMENTS THAT  
15 ARE DISTINCT FROM THE REQUIREMENTS SET FORTH IN THIS SECTION OR  
16 ESTABLISHED BY THE BOARD PURSUANT TO THIS SECTION, THE  
17 COMMISSION MAY, BY RULE AND IN CONSULTATION WITH THE BOARD,  
18 ESTABLISH REQUIREMENTS THAT COMPLY WITH THE FCC'S CONDITIONS;  
19 EXCEPT THAT ANY REQUIREMENTS ESTABLISHED BY THE COMMISSION BY  
20 RULE PURSUANT TO THIS SUBSECTION (10.5)(b) MUST APPLY ONLY TO  
21 BROADBAND DEPLOYMENT PROJECTS THAT ARE ELIGIBLE TO RECEIVE  
22 AUCTION MONEY.

23 (c) AS USED IN THIS SUBSECTION (10.5):

24 (I) "AUCTION RULES" REFERS TO THE FCC'S RULES IN 47 CFR  
25 54.309 TO 54.316, WHICH RULES CONCERN THE IMPLEMENTATION OF THE  
26 CONNECT AMERICA FUND PHASE II AUCTION.

27 (II) "CONNECT AMERICA FUND PHASE II AUCTION" OR "AUCTION"

1 REFERS TO A TEN-YEAR AUCTION OF FEDERAL MONEY THROUGH WHICH  
2 THE FCC WILL ALLOCATE MONEY, BY MEANS OF A COMPETITIVE BIDDING  
3 PROCESS, TO TELECOMMUNICATIONS PROVIDERS WHO COMMIT TO  
4 PROVIDING VOICE AND BROADBAND SERVICE IN HIGH-COST AREAS OF THE  
5 NATION IN ACCORDANCE WITH THE FCC'S AUCTION RULES.

6 (III) "NEW YORK'S PETITION FOR EXPEDITED WAIVER" REFERS TO  
7 A PETITION THAT THE STATE OF NEW YORK FILED WITH THE FCC SEEKING  
8 A WAIVER FROM THE FCC'S AUCTION RULES WITH REGARD TO THE RULES'  
9 LIMITATION PROHIBITING STATE ENTITIES FROM APPLYING FOR FEDERAL  
10 MONEY THROUGH THE AUCTION. THE FCC GRANTED THE WAIVER REQUEST  
11 ON JANUARY 26, 2017, THUS AUTHORIZING THE STATE OF NEW YORK TO  
12 DIRECTLY RECEIVE AND ALLOCATE AUCTION MONEY TO BROADBAND  
13 PROJECTS WITHIN THE STATE.

14 **SECTION 2. Safety clause.** The general assembly hereby finds,  
15 determines, and declares that this act is necessary for the immediate  
16 preservation of the public peace, health, and safety.
