A BILL FOR AN ACT CONCERNING MODIFICATIONS TO THE "NATUROPATHIC DOCTOR ACT", AND, IN CONNECTION THEREWITH, REQUIRING A NATUROPATHIC DOCTOR TO DISCLOSE THAT THE NATUROPATHIC DOCTOR IS REGISTERED AND UPDATING THE TERMS THAT A NATUROPATHIC DOCTOR MAY USE.

Bill Summary

As it relates to naturopathic doctors, the bill:

doctor can use the term "physician". Be it enacted by the General Assembly of the State of Colorado: **SECTION 1.** In Colorado Revised Statutes, 12-37.3-105, amend (3)(b) as follows: 12-37.3-105. Practice of naturopathic medicine by naturopathic doctors - exclusions - protected activities - rules. (3) (b) Before conducting an initial examination of a patient, a naturopathic doctor shall obtain the patient's informed consent to the examination, evidenced by a written statement in a form prescribed by the director and signed by both the patient and the naturopathic doctor. The statement must: (I) Disclose that the naturopathic doctor is not a medical doctor or physician licensed under article 36 of this title 12; (II) Recommend that the patient have a relationship with a licensed physician; and (III) Indicate that the naturopathic doctor will attempt to develop and maintain a collaborative relationship with the patient's physician, if the patient has a relationship with a licensed physician; AND (IV) DISCLOSE THAT THE NATUROPATHIC DOCTOR IS REGISTERED. **SECTION 2.** In Colorado Revised Statutes, 12-37.3-110, amend (2), (3)(a), and (4); and **add** (2.5) as follows: 12-37.3-110.
