After consideration on the merits, the Committee recommends the following:

HB18-1316 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, after line 1 insert:

2 "SECTION 1. In Colorado Revised Statutes, 8-83-303, **add** (2.5)  
3 as follows:

4 **8-83-303. Definitions.** As used in this part 3 unless the context  
5 otherwise requires:

6 (2.5) "COUNCIL" MEANS THE STATE WORK FORCE DEVELOPMENT  
7 COUNCIL CREATED IN SECTION 24-46.3-101."

8 Renumber succeeding sections accordingly.

9 Page 2, line 3, strike "(1)(d) introductory portion," and substitute  
10 "(1)(d),".

11 Page 2, strike lines 16 through 18.

12 Page 3, strike line 1 and substitute "procedure for accepting and  
13 reviewing ~~an application~~ APPLICATIONS from an eligible applicant that  
14 received matching grant awards in the 2015-16 or 2016-17 fiscal year and  
15 is applying for an additional matching grant or to extend a matching grant  
16 award under an existing agreement if APPLICANTS.

17 ~~(f) The eligible applicant demonstrates positive outcomes~~  
18 ~~resulting from its receipt and use of matching grants under the WORK~~  
19 ~~grant program;~~

1           ~~(H) The eligible applicant demonstrates that all organizations that~~  
2 ~~were named in the original grant application agree to participate in an~~  
3 ~~expedited application process; and~~

4           ~~(H) The WORK grant review committee approves the use of an~~  
5 ~~expedited application process for the eligible applicant."~~

6 Page 3, line 11, before "(2)(c)" insert "(1) introductory portion, (1)(i),  
7 and".

8 Page 3, strike line 14 and substitute "**grant award recommendations.**

9 (1) There is created the skilled worker outreach, recruitment, and key  
10 training grant review committee, also referred to as the "WORK grant  
11 review committee". The grant review committee consists of thirteen  
12 members appointed by the ~~governor~~ COUNCIL as follows:

13           (i) One member of the ~~state work force development council~~  
14 ~~created in section 24-46.3-101, C.R.S.~~

15           (2) (c) (I) After reviewing the grant".

16 Page 3, line 22, after "to" insert "THE EXECUTIVE COMMITTEE OF THE  
17 COUNCIL, WHICH INCLUDES".

18 Page 3, line 26, strike "directors and the director shall jointly" and  
19 substitute "~~directors and the director~~ COMMITTEE shall jointly".

20 Page 4, line 2, strike "AND" and substitute "AND, TO THE EXTENT  
21 POSSIBLE,".

22 Page 4, line 6, strike "ENSURE" and substitute "ENSURE, TO THE EXTENT  
23 POSSIBLE,".

24 Page 4, line 8, strike "ENSURE" and substitute "ENSURE, TO THE EXTENT  
25 POSSIBLE,".

26 Page 4, strike lines 13 through 16 and substitute:

27           "**8-83-306. Reports.** (2) ~~By May 1, 2017, and by each May 1~~  
28 ~~thereafter through May 1, 2020~~ BY DECEMBER 31, 2018, AND BY EACH  
29 DECEMBER 31 THEREAFTER, the grant review committee".

30 Page 4, line 17, strike "submit" and substitute "submit, AS PART OF THE  
31 COLORADO TALENT PIPELINE REPORT PREPARED PURSUANT TO SECTION

1 24-46.3-103,".

2 Page 4, line 24, strike "(3)" and substitute "(1)(b), (3), and (5)".

3 Page 4, line 27, strike "(3) (a) For the 2015-16," and substitute  
4 "(1) (b) EXCEPT AS PROVIDED IN SUBSECTION (5) OF THIS SECTION, the  
5 ~~moneys~~ MONEY in the fund ~~are~~ IS subject to annual appropriation by the  
6 general assembly to the department for the direct and indirect costs  
7 associated with implementing this part 3.

8 (3) (a) For the 2015-16,".

9 Page 5, line 4, strike "EXPENDED" and substitute "APPROPRIATED".

10 Page 5, line 6, strike "MUST BE ALLOCATED" and substitute "SHOULD BE  
11 ALLOCATED, TO THE EXTENT POSSIBLE,".

12 Page 5, after line 12 insert:

13 (5) Any unexpended and unencumbered ~~moneys~~ MONEY  
14 remaining in the WORK fund at the end of a fiscal year ~~remain~~ REMAINS  
15 in the fund and shall not be credited or transferred to the general fund or  
16 another fund. UNEXPENDED AND UNENCUMBERED MONEY FROM AN  
17 APPROPRIATION MADE PURSUANT TO SUBSECTION (3) OF THIS SECTION  
18 REMAINS AVAILABLE FOR EXPENDITURE BY THE DEPARTMENT IN THE NEXT  
19 FISCAL YEAR WITHOUT FURTHER APPROPRIATION."
