**Wildfire Matters Review Committee.** The bill requires the center of excellence for advanced technology aerial firefighting, subject to available appropriations, to study and, if feasible, implement a system to patrol the airspace above a wildland fire.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-33.5-1228, **add**  
3 (2.5)(e) as follows:

4           **24-33.5-1228. Colorado firefighting air corps - creation -**  
5 **powers - aircraft acquisitions required - center of excellence -**  
6 **unmanned aircraft systems study and pilot program - Colorado**  
7 **firefighting air corps fund - creation - report - rules.**

8 (2.5) (e) SUBJECT TO AVAILABLE APPROPRIATIONS, THE CENTER OF  
9 EXCELLENCE SHALL STUDY AND, IF FEASIBLE, IMPLEMENT A SYSTEM TO  
10 PATROL THE AIRSPACE ABOVE A WILDLAND FIRE. THE PATROL SYSTEM  
11 MUST BE CAPABLE OF DETERMINING WHETHER THE AIRSPACE ABOVE  
12 WILDLAND FIRES IS CLEAR OF OBSTACLES, INCLUDING PRIVATE UNMANNED  
13 AIRCRAFT SYSTEMS, THAT MAY INTERFERE WITH AERIAL FIREFIGHTING.

14           **SECTION 2. Appropriation.** For the 2019-20 state fiscal year,  
15 \$350,000 is appropriated to the department of public safety for use by the  
16 division of fire prevention and control. This appropriation is from the  
17 general fund. To implement this act, the division may use this  
18 appropriation for wildland fire management services.

19           **SECTION 3. Act subject to petition - effective date.** This act  
20 takes effect at 12:01 a.m. on the day following the expiration of the  
21 ninety-day period after final adjournment of the general assembly (August  
22 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a  
23 referendum petition is filed pursuant to section 1 (3) of article V of the  
24 state constitution against this act or an item, section, or part of this act  
25 within such period, then the act, item, section, or part will not take effect  
26 unless approved by the people at the general election to be held in

- 1 November 2020 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
