101      **CONCERNING CREATION OF THE COLORADO YOUTH ADVISORY**  
102              **COUNCIL REVIEW COMMITTEE, AND, IN CONNECTION**  
103              **THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The Colorado youth advisory council (council) is comprised of 4 legislative members and 40 nonlegislative members who are between 14 and 19 years of age. The council meets 4 times each year to examine, evaluate, and discuss the issues, interests, and needs affecting Colorado youth. On or before April 30 each year, the council reports to legislative

committees a summary of the council's work and recommendations.

The bill creates the Colorado youth advisory council review committee (review committee). The review committee is comprised of the legislative members of the council, 5 nonlegislative council members who are appointed by the council, and one member of the legislative council. The 5 legislative members of the review committee serve as voting members. All other members are nonvoting members. The review committee may meet up to 3 times each interim and recommend up to 3 bills to the legislative council.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-2-1301.5, **add** (4)  
3 as follows:

4 **2-2-1301.5. Definitions.** As used in this part 13, unless the  
5 context otherwise requires:

6 (4) "REVIEW COMMITTEE" MEANS THE COLORADO YOUTH  
7 ADVISORY COUNCIL REVIEW COMMITTEE CREATED IN SECTION 2-2-1305.5.

8 **SECTION 2.** In Colorado Revised Statutes, 2-2-1304, **add** (6) as  
9 follows:

10 **2-2-1304. Duties - meetings - community outreach -**  
11 **designation of organization to accept donations - authority to**  
12 **contract - repeal.** (6) (a) (I) ON OR BEFORE JULY 15, 2019, THE COUNCIL  
13 SHALL SELECT FIVE MEMBERS TO SERVE AS NONVOTING MEMBERS OF THE  
14 REVIEW COMMITTEE DURING THE 2019 INTERIM.

15 (II) THIS SUBSECTION (6)(a) IS REPEALED, EFFECTIVE JUNE 30,  
16 2020.

17 (b) ON OR BEFORE APRIL 30, 2020, AND ON OR BEFORE APRIL 30  
18 OF EACH YEAR THEREAFTER, THE COUNCIL SHALL SELECT FIVE MEMBERS  
19 TO SERVE AS NONVOTING MEMBERS OF THE REVIEW COMMITTEE DURING  
20 THE SUBSEQUENT LEGISLATIVE INTERIM.

1 (c) THE COUNCIL SHALL NOTIFY THE DIRECTOR OF RESEARCH OF  
2 THE LEGISLATIVE COUNCIL OF THE APPOINTMENTS MADE PURSUANT TO  
3 THIS SUBSECTION (6).

4 **SECTION 3.** In Colorado Revised Statutes, **add 2-2-1305.5** as  
5 follows:

6 **2-2-1305.5. Colorado youth advisory council review committee**  
7 **- created - repeal.** (1) THERE IS CREATED IN THE LEGISLATIVE BRANCH  
8 THE COLORADO YOUTH ADVISORY COUNCIL REVIEW COMMITTEE TO  
9 REVIEW THE COUNCIL'S WORK AND TO RECOMMEND LEGISLATION  
10 REGARDING ISSUES AFFECTING COLORADO YOUTH. THE COMMITTEE IS  
11 COMPRISED OF TEN MEMBERS, AS DESCRIBED IN SUBSECTION (2) OF THIS  
12 SECTION.

13 (2) (a) THE REVIEW COMMITTEE INCLUDES FIVE VOTING MEMBERS,  
14 AS FOLLOWS:

15 (I) THE FOUR LEGISLATIVE MEMBERS OF THE COUNCIL, AS  
16 DESCRIBED IN SECTION 2-2-1303 (1)(a); AND

17 (II) ONE MEMBER OF THE LEGISLATIVE COUNCIL, CREATED IN  
18 SECTION 2-3-301, APPOINTED PURSUANT TO SUBSECTION (3) OF THIS  
19 SECTION.

20 (b) THE REVIEW COMMITTEE INCLUDES AS NONVOTING MEMBERS  
21 FIVE MEMBERS OF THE COUNCIL, APPOINTED PURSUANT TO SECTION  
22 2-2-1304 (6).

23 (3) (a) (I) ON OR BEFORE JULY 15, 2019, THE CHAIR OF THE  
24 LEGISLATIVE COUNCIL SHALL APPOINT THE MEMBER SERVING PURSUANT  
25 TO SUBSECTION (2)(a)(II) OF THIS SECTION TO SERVE DURING THE 2019  
26 INTERIM.

27 (II) THIS SUBSECTION (3)(a) IS REPEALED, EFFECTIVE JUNE 30,

1 2020.

2 (b) ON OR BEFORE APRIL 30, 2020, AND ON OR BEFORE APRIL 30  
3 OF EACH YEAR THEREAFTER, THE CHAIR OF THE LEGISLATIVE COUNCIL  
4 SHALL APPOINT THE MEMBER SERVING PURSUANT TO SUBSECTION  
5 (2)(a)(II) OF THIS SECTION TO SERVE DURING THE SUBSEQUENT  
6 LEGISLATIVE INTERIM.

7 (4) THE CHAIR OF THE REVIEW COMMITTEE IS THE LEGISLATIVE  
8 MEMBER WHO IS SERVING AS A CO-CHAIR OF THE COUNCIL PURSUANT TO  
9 SECTION 2-2-1303 (4). THE VICE-CHAIR OF THE REVIEW COMMITTEE IS THE  
10 LEGISLATIVE MEMBER WHO IS SERVING AS A VICE-CHAIR OF THE COUNCIL  
11 PURSUANT TO SECTION 2-2-1303 (4).

12 (5) THE REVIEW COMMITTEE MAY MEET UP TO THREE TIMES  
13 DURING EACH INTERIM BUT MAY NOT TRAVEL UNLESS AUTHORIZED BY THE  
14 EXECUTIVE COMMITTEE OF THE LEGISLATIVE COUNCIL. A MAJORITY OF  
15 VOTING MEMBERS CONSTITUTES A QUORUM.

16 (6) THE REVIEW COMMITTEE MAY RECOMMEND UP TO A TOTAL OF  
17 THREE BILLS DURING EACH INTERIM. LEGISLATION RECOMMENDED BY THE  
18 REVIEW COMMITTEE MUST BE TREATED AS LEGISLATION RECOMMENDED  
19 BY AN INTERIM COMMITTEE FOR PURPOSES OF APPLICABLE DEADLINES,  
20 BILL INTRODUCTION LIMITS, AND ANY OTHER REQUIREMENTS IMPOSED BY  
21 THE JOINT RULES OF THE GENERAL ASSEMBLY.

22 (7) VOTING MEMBERS OF THE REVIEW COMMITTEE ARE ENTITLED  
23 TO COMPENSATION PURSUANT TO SECTION 2-2-307. SUBJECT TO  
24 AVAILABLE FUNDS, NONVOTING MEMBERS MAY RECEIVE REIMBURSEMENT  
25 FOR EXPENSES FROM THE FUND CREATED IN SECTION 2-2-1306.

26 (8) THE LEGISLATIVE COUNCIL STAFF AND THE STAFF OF THE  
27 OFFICE OF LEGISLATIVE LEGAL SERVICES SHALL ASSIST THE REVIEW

1 COMMITTEE IN CARRYING OUT ITS DUTIES PURSUANT TO THIS SECTION.

2 **SECTION 4.** In Colorado Revised Statutes, **amend** 2-2-1306 as  
3 follows:

4 **2-2-1306. Youth advisory council cash fund - created - gifts,**  
5 **grants, and donations.** There is hereby created in the state treasury the  
6 youth advisory council cash fund to provide for the direct and indirect  
7 costs associated with the implementation of this part 13, including but not  
8 limited to lodging, meeting fees, mileage and transportation costs, meals,  
9 meeting supplies, copy costs, computer-related costs, and any services for  
10 which the council contracts, AND EXPENSES INCURRED BY NONVOTING  
11 MEMBERS OF THE REVIEW COMMITTEE. The fund shall consist of any  
12 ~~moneys~~ MONEY appropriated by the general assembly to the fund and may  
13 also include gifts, grants, and donations obtained directly by the council  
14 pursuant to this section. The council is authorized to seek and accept  
15 gifts, grants, or donations from private or public sources for the purposes  
16 of this part 13. All private and public ~~moneys~~ MONEY received by the  
17 council through gifts, grants, or donations shall be transmitted to the state  
18 treasurer, who shall credit the same to the fund. The ~~moneys~~ MONEY in  
19 the fund shall be continuously appropriated for the direct and indirect  
20 costs associated with the implementation of this part 13. Any ~~moneys~~  
21 MONEY in the fund not expended for the purposes of this part 13 may be  
22 invested by the state treasurer as provided by law. All interest and income  
23 derived from the investment and deposit of ~~moneys~~ MONEY in the fund  
24 shall be credited to the fund. Any unexpended and unencumbered ~~moneys~~  
25 MONEY remaining in the fund at the end of a fiscal year ~~shall remain~~  
26 REMAINS in the fund and shall not be credited or transferred to the general  
27 fund or another fund.

1           **SECTION 5. Appropriation.** (1) For the 2019-20 state fiscal  
2 year, \$28,790 is appropriated to the legislative department. This  
3 appropriation is from the general fund. To implement this act, the  
4 department may use this appropriation as follows:

5           (a) \$18,455 for use by the legislative council staff, which amount  
6 is based on an assumption that the legislative council staff will require an  
7 additional 0.3 FTE;

8           (b) \$6,889 for use by committee on legal services, which amount  
9 is based on an assumption that the committee on legal services will  
10 require an additional 0.1 FTE; and

11           (c) \$3,446 for use by general assembly.

12           **SECTION 6. Safety clause.** The general assembly hereby finds,  
13 determines, and declares that this act is necessary for the immediate  
14 preservation of the public peace, health, and safety.
