1           **SECTION 3. Appropriation to the department of health care**  
2 **policy and financing for the fiscal year beginning July 1, 2017.** (1) For  
3 the 2017-18 state fiscal year, \$26,943,875 is appropriated to the  
4 department of health care policy and financing and is for the payment of  
5 overexpenditures of line item appropriations contained in Part V of  
6 section 2 of chapter 421 (SB 17-254), Session Laws of Colorado 2017,  
7 as follows:

8           (a) \$17,847,003 from the general fund for medical services  
9 premiums;

10           (b) \$444,003 from the general fund for behavioral health capitation  
11 payments;

12           (c) \$1,265,019 for the children's basic health plan medical and  
13 dental costs, which consists of \$523,427 from the children's basic health  
14 plan trust fund created in section 25.5-8-105 (1), C.R.S., and \$741,592  
15 from recoveries and recoupments; and

16           (d) \$7,387,850 for mental health institutes, which consists of  
17 \$3,694,541 from the general fund and \$3,693,309 from federal funds.

18           (2) In accordance with section 24-75-109 (4)(a), C.R.S., all  
19 restrictions on funds for the department of health care policy and  
20 financing for the 2018-19 state fiscal year for the amounts and items of  
21 appropriation listed in this section are released.

22           **SECTION 4. Safety clause.** The general assembly hereby finds,  
23 determines, and declares that this act is necessary for the immediate  
24 preservation of the public peace, health, and safety.
