A BILL FOR AN ACT

101 **CONCERNING THE COMPENSATION PAYABLE TO A MEMBER OF A BOARD**
102 **OF DIRECTORS OF AN URBAN DRAINAGE AND FLOOD CONTROL**
103 **DISTRICT.**

Bill Summary

A member of a board of directors of an urban drainage and flood control district is currently limited to receiving \$1,200 per year as compensation, not to exceed \$75 per meeting attended. The bill changes these maximum amounts to be the same as the amounts allowed for directors of special districts generally, which is currently specified in

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 32-11-212, **amend**
3 (1)(a) as follows:

4 **32-11-212. Compensation of directors.** (1) (a) (I) For directors
5 serving a term of office commencing prior to ~~April 24, 1996~~ JANUARY 1,
6 2019, each director shall receive as compensation for the director's
7 services a sum, not in excess of ~~two hundred forty dollars per annum~~ ONE
8 THOUSAND TWO HUNDRED DOLLARS PER ANNUM, which shall be set by the
9 board on a regular or special meeting basis ~~but~~ AND WHICH SHALL NOT
10 EXCEED SEVENTY-FIVE DOLLARS PER MEETING. A director shall not be
11 compensated for any meeting that the director fails to attend.

12 (II) For directors serving a term of office commencing on or after
13 ~~April 24, 1996~~ JANUARY 1, 2019, each director shall receive as
14 compensation for the director's services a sum, not in excess of ~~one~~
15 ~~thousand two hundred dollars per annum, which shall be set by the board~~
16 ~~on a regular or special meeting basis and which shall not exceed~~
17 ~~seventy-five dollars per meeting attended~~ THE SUMS SET FORTH IN
18 SECTION 32-1-902 (3)(a)(II). A director shall not be compensated for any
19 meeting that the director fails to attend.

20 **SECTION 2. Act subject to petition - effective date.** This act
21 takes effect at 12:01 a.m. on the day following the expiration of the
22 ninety-day period after final adjournment of the general assembly (August
23 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a
24 referendum petition is filed pursuant to section 1 (3) of article V of the
25 state constitution against this act or an item, section, or part of this act

1 within such period, then the act, item, section, or part will not take effect
2 unless approved by the people at the general election to be held in
3 November 2020 and, in such case, will take effect on the date of the
4 official declaration of the vote thereon by the governor.
