**A BILL FOR AN ACT**

101      **CONCERNING THE NOTICE REQUIREMENTS OF EMPLOYERS WITH**  
102      **REGARD TO THE SHARING OF GRATUITIES.**

**Bill Summary**

Current law authorizes an employer to require employees to share gratuities if the employer posts a sign in a conspicuous place. The bill changes this law by requiring notification to each patron in writing, such as on the menu, table, or receipt.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** The general assembly  
3 hereby declares that this act does not change who may participate in the  
4 sharing of gratuities or who may be required to share gratuities and does  
5 not change the legal minimum wage for any person in Colorado.

6 **SECTION 2.** In Colorado Revised Statutes, 8-4-103, **amend** (6)  
7 as follows:

8 **8-4-103. Payment of wages - insufficient funds - pay statement**  
9 **- record retention - gratuity notification.** (6) It is unlawful for ~~any~~ AN  
10 employer engaged in ~~any~~ A business where the custom prevails of the  
11 giving of ~~presents, tips, or~~ gratuities by patrons ~~thereof~~ to an employee of  
12 ~~said~~ THE business to assert ~~any~~ A claim to, or right of ownership in, or  
13 control over ~~such presents, tips, or~~ gratuities. ~~and such presents, tips, or~~  
14 THESE gratuities ~~shall be~~ ARE the sole property of the employee of ~~said~~  
15 business unless the employer ~~posts in his or her place of business in a~~  
16 conspicuous place a printed card, at least twelve inches by fifteen inches  
17 in size, containing a notice to the general public in letters at least one-half  
18 inch high that all ~~presents, tips, or~~ gratuities given by any patron of ~~said~~  
19 business to an employee thereof are not the property of ~~said~~ employee but  
20 ~~belong to the employer~~ NOTIFIES EACH PATRON IN WRITING, INCLUDING BY  
21 A NOTICE ON A MENU, TABLE TENT, OR RECEIPT, THAT GRATUITIES ARE  
22 SHARED BY EMPLOYEES. Nothing in this section ~~shall prevent~~ PREVENTS  
23 an employer ~~covered hereby~~ from requiring employees to share or  
24 allocate ~~such presents, tips, or~~ gratuities on a preestablished basis among  
25 the employees of ~~such~~ THE business.

26 **SECTION 3. Act subject to petition - effective date -**  
27 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following

1 the expiration of the ninety-day period after final adjournment of the  
2 general assembly (August 2, 2019, if adjournment sine die is on May 3,  
3 2019); except that, if a referendum petition is filed pursuant to section 1  
4 (3) of article V of the state constitution against this act or an item, section,  
5 or part of this act within such period, then the act, item, section, or part  
6 will not take effect unless approved by the people at the general election  
7 to be held in November 2020 and, in such case, will take effect on the  
8 date of the official declaration of the vote thereon by the governor.

9 (2) This act applies to gratuities given on or after the applicable  
10 effective date of this act.
