Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. School Safety Committee. The bill creates the Colorado interagency working group on school safety. The working group consists of 14 voting members, including 4 legislative members. The mission of the working group is to enhance school safety through the cost-effective use of public resources. The working group shall:

! Study and implement recommendations of the state

auditor's report regarding school safety released September 2019;

- ! Study the use of lockdown drills, including their effectiveness and any harm they do to the participating students;
- ! Identify school safety best practices and then rank the effectiveness of the best practices;
- ! Identify actions to improve transparency, reduce duplication, improve services, and improve communication;
- ! Create minimum school safety standards;
- ! Provide school risk assessments and training;
- ! Develop standardized language for describing threats to schools and the procedures to be followed in investigating a threat;
- ! Create a list of approved school safety resource vendors and tools;
- ! Recommend minimum standards or procedural guidelines for behavioral threat assessment tools;
- ! Report on a monthly basis aggregated behavioral and risk assessment data;
- ! Create an annual report of findings and recommendations, including evidence-based analysis and data; and
- ! Study and evaluate the implemented changes.

The working group may contract with a consultant to optimize the alignment and effectiveness of the school safety efforts in Colorado and identify evidence-based best practices. The general assembly may appropriate money to the working group for a consultant, and the working group can accept gifts, grants, and donations.

The bill repeals the working group on September 1, 2023.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** article 25 to title
3 **24** as follows:

4 **ARTICLE 25**

5 **Colorado Interagency Working Group on School Safety**

6 **24-25-101. Legislative declaration.** (1) THE GENERAL ASSEMBLY
7 **FINDS AND DECLARES THAT:**

8 **(a) ENSURING THE SAFETY OF STUDENTS, TEACHERS, AND OTHER**

1 EMPLOYEES WHILE AT SCHOOL IS A PARAMOUNT CONCERN FOR THE
2 CITIZENS OF COLORADO;

3 (b) IMPROVING THE EFFECTIVE ADMINISTRATION OF SCHOOL
4 SAFETY PROGRAMS AND FUNDING IS CRITICAL TO PROVIDING SAFE
5 SCHOOLS; AND

6 (c) MAINTAINING SCHOOL SAFETY THROUGH THE MOST
7 COST-EFFECTIVE USE OF LIMITED STATE RESOURCES IS IN THE INTEREST OF
8 THE PEOPLE OF THE STATE OF COLORADO.

9 (2) THEREFORE, THE GENERAL ASSEMBLY DECLARES THAT A
10 WORKING GROUP COMPRISED OF STATE AND LOCAL AGENCY OFFICIALS
11 MUST BE FORMED TO INCREASE COORDINATION OF SCHOOL SAFETY
12 PROGRAMS ACROSS STATE GOVERNMENT AND ANNUALLY REPORT TO THE
13 GOVERNOR, THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND THE
14 PRESIDENT OF THE SENATE ON THEIR ACTIVITIES.

15 **24-25-102. Colorado interagency working group on school**
16 **safety - creation - membership - operation - immunity.** (1) THERE IS
17 HEREBY CREATED IN THE DEPARTMENT THE COLORADO INTERAGENCY
18 WORKING GROUP ON SCHOOL SAFETY, REFERRED TO IN THIS ARTICLE 25 AS
19 THE "WORKING GROUP". THE WORKING GROUP HAS THE POWERS AND
20 DUTIES SPECIFIED IN THIS ARTICLE 25.

21 (2) THE WORKING GROUP CONSISTS OF THIRTEEN MEMBERS, AS
22 FOLLOWS:

23 (a) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PUBLIC
24 SAFETY, OR HIS OR HER DESIGNEE, WHO SHALL SERVE AS THE CHAIR OF THE
25 WORKING GROUP;

26 (b) THE COMMISSIONER OF EDUCATION, OR HIS OR HER DESIGNEE,
27 WHO SHALL SERVE AS THE VICE-CHAIR OF THE WORKING GROUP;

1 (c) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PUBLIC
2 HEALTH AND ENVIRONMENT, OR HIS OR HER DESIGNEE;

3 (d) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF HUMAN
4 SERVICES, OR HIS OR HER DESIGNEE;

5 (e) THE ATTORNEY GENERAL, OR HIS OR HER DESIGNEE;

6 (f) THE DIRECTOR OF THE SCHOOL SAFETY RESOURCE CENTER;

7 (g) THE DIRECTOR OF THE DIVISION OF FIRE PREVENTION AND
8 CONTROL OR HIS OR HER DESIGNEE;

9 (h) A SCHOOL DISTRICT SUPERINTENDENT WHO SERVES AN URBAN
10 OR SUBURBAN SCHOOL DISTRICT, APPOINTED BY AN ORGANIZATION THAT
11 REPRESENTS SCHOOL EXECUTIVES;

12 (i) A SCHOOL DISTRICT SUPERINTENDENT WHO SERVES A RURAL
13 SCHOOL DISTRICT, APPOINTED BY AN ORGANIZATION THAT REPRESENTS
14 SCHOOL EXECUTIVES;

15 (j) A CHIEF OF POLICE APPOINTED BY AN ORGANIZATION THAT
16 REPRESENTS COLORADO CHIEFS OF POLICE;

17 (k) A COUNTY SHERIFF APPOINTED BY AN ORGANIZATION THAT
18 REPRESENTS COLORADO COUNTY SHERIFFS; AND

19 (l) TWO MEMBERS WHO ARE EITHER A STUDENT OR PARENT WHO
20 ATTENDED A SCHOOL OR HAD A CHILD ATTEND A SCHOOL AT THE TIME A
21 SCHOOL SHOOTING OCCURRED AT THE SCHOOL, ONE APPOINTED BY THE
22 MAJORITY LEADER OF THE SENATE AND ONE APPOINTED BY THE MINORITY
23 LEADER OF THE SENATE.

24 (3) THE MEMBERS OF THE WORKING GROUP SERVE WITHOUT
25 COMPENSATION BUT THE MEMBERS APPOINTED BY THE GOVERNOR MAY BE
26 REIMBURSED FOR ANY ACTUAL AND NECESSARY TRAVEL EXPENSES
27 INCURRED IN THE PERFORMANCE OF THEIR DUTIES PURSUANT TO THIS

1 ARTICLE 25.

2 (4) THE WORKING GROUP SHALL MEET AT LEAST ONCE PER
3 QUARTER TO REVIEW INFORMATION NECESSARY FOR MAKING
4 RECOMMENDATIONS.

5 (5) THE WORKING GROUP MAY CONTRACT WITH A CONSULTANT TO
6 OPTIMIZE THE ALIGNMENT AND EFFECTIVENESS OF THE SCHOOL SAFETY
7 EFFORTS IN COLORADO AND IDENTIFY EVIDENCE-BASED BEST PRACTICES.
8 THE GENERAL ASSEMBLY MAY APPROPRIATE MONEY TO THE WORKING
9 GROUP FOR A CONSULTANT IF REQUESTED BY THE WORKING GROUP.

10 (6) MEMBERS OF THE WORKING GROUP, EMPLOYEES, AND
11 CONSULTANTS ARE IMMUNE FROM SUIT IN ANY CIVIL ACTION BASED UPON
12 ANY OFFICIAL ACT PERFORMED IN GOOD FAITH PURSUANT TO THIS ARTICLE
13 25.

14 (7) THE WORKING GROUP SHALL ONLY MEET IF THE DEPARTMENT
15 OF PUBLIC SAFETY IDENTIFIES SUFFICIENT FUNDING TO COVER THE COSTS
16 ASSOCIATED WITH THE WORKING GROUP.

17 **24-25-103. Duties of the working group - mission.** (1) THE
18 MISSION OF THE WORKING GROUP IS TO ENHANCE SCHOOL SAFETY
19 THROUGH THE COST-EFFECTIVE USE OF PUBLIC RESOURCES. THE WORK OF
20 THE WORKING GROUP WILL FOCUS ON EVIDENCE-BASED BEST PRACTICES.

21 (2) THE WORKING GROUP SHALL:

22 (a) STUDY AND IMPLEMENT RECOMMENDATIONS OF THE STATE
23 AUDITOR'S REPORT REGARDING SCHOOL SAFETY RELEASED SEPTEMBER
24 2019;

25 (b) CONSIDER PROGRAM ORGANIZATION AND RECOMMEND
26 REORGANIZATION IF NECESSARY;

27 (c) IDENTIFY SHARED METRICS TO EXAMINE PROGRAM

1 EFFECTIVENESS:

2 (d) FACILITATE INTERAGENCY COORDINATION AND
3 COMMUNICATION:

4 (e) INCREASE TRANSPARENCY AND ACCESSIBILITY OF STATE
5 GRANTS AND RESOURCES, PARTICULARLY FOR SCHOOL DISTRICTS WITHOUT
6 A GRANT WRITER, WHICH INCLUDES IMPROVING OUTREACH AND MAY
7 INCLUDE DEVELOPING COMMON GRANT APPLICATIONS:

8 (f) FACILITATE AND ADDRESS DATA SHARING, INCLUDING
9 ALLOWABLE DATA SHARING AT THE LOCAL LEVEL, WHEN APPROPRIATE
10 AND ALLOWABLE UNDER STATE AND FEDERAL LAW; AND

11 (g) ADDRESS SCHOOL SAFETY PROGRAM CHALLENGES IN A
12 COORDINATED WAY.

13 (3) THE WORKING GROUP MAY USE AVAILABLE RESOURCES,
14 MODALITIES, AND NONMEMBERS FROM INTERESTED MEMBERS OF THE
15 COMMUNITY TO FOCUS ON SPECIFIC SUBJECT MATTERS.

16 (4) THE SCHOOL SAFETY RESOURCE CENTER SERVES AS THE
17 CLEARINGHOUSE FOR ALL MATERIALS PRODUCED BY THE WORKING GROUP.

18 (5) THE DIVISION OF CRIMINAL JUSTICE IN THE DEPARTMENT OF
19 PUBLIC SAFETY, IN CONSULTATION WITH THE DEPARTMENT OF EDUCATION,
20 SHALL PROVIDE RESOURCES FOR DATA COLLECTION, RESEARCH, ANALYSIS,
21 AND PUBLICATION OF THE WORKING GROUP'S FINDINGS AND REPORTS.

22 **24-25-104. Colorado working group on school safety cash fund**
23 **- created - gifts, grants, and donations. (1) THE DEPARTMENT OF**
24 **PUBLIC SAFETY AND THE WORKING GROUP ARE AUTHORIZED TO ACCEPT**
25 **GIFTS, GRANTS, OR DONATIONS, INCLUDING IN-KIND DONATIONS FROM**
26 **PRIVATE OR PUBLIC SOURCES, FOR THE PURPOSES OF THIS ARTICLE 25. ALL**
27 **PRIVATE AND PUBLIC MONEY RECEIVED THROUGH GIFTS, GRANTS, OR**

1 DONATIONS BY THE DEPARTMENT OF PUBLIC SAFETY OR BY THE WORKING
2 GROUP MUST BE TRANSMITTED TO THE STATE TREASURER, WHO SHALL
3 CREDIT THE SAME TO THE COLORADO WORKING GROUP ON SCHOOL SAFETY
4 CASH FUND, WHICH FUND IS CREATED IN THE STATE TREASURY AND
5 REFERRED TO IN THIS ARTICLE 25 AS THE "CASH FUND". THE STATE
6 TREASURER SHALL INVEST ANY MONEY IN THE CASH FUND NOT EXPENDED
7 FOR THE PURPOSES OF THIS ARTICLE 25 AS PROVIDED IN SECTION
8 24-36-113. ALL INTEREST AND INCOME DERIVED FROM THE INVESTMENT
9 AND DEPOSIT OF MONEY IN THE CASH FUND MUST BE CREDITED TO THE
10 CASH FUND. ANY UNEXPENDED AND UNENCUMBERED MONEY REMAINING
11 IN THE CASH FUND AT THE END OF ANY FISCAL YEAR REMAINS IN THE CASH
12 FUND AND SHALL NOT BE CREDITED OR TRANSFERRED TO THE GENERAL
13 FUND OR ANY OTHER FUND.

14 (2) THE DEPARTMENT OF PUBLIC SAFETY IS NOT REQUIRED TO
15 SOLICIT GIFTS, GRANTS, OR DONATIONS FROM ANY SOURCE FOR THE
16 PURPOSES OF THIS ARTICLE 25.

17 **22-25-105. Repeal of article.** THIS ARTICLE 25 IS REPEALED,
18 EFFECTIVE SEPTEMBER 1, 2022. BEFORE THE REPEAL, THE DEPARTMENT
19 OF REGULATORY AGENCIES SHALL REVIEW THE WORKING GROUP AS
20 DESCRIBED IN SECTION 2-3-1203.

21 **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **add**
22 (13)(a)(VI) as follows:

23 **2-3-1203. Sunset review of advisory committees - legislative**
24 **declaration - definition - repeal.** (13) (a) The following statutory
25 authorizations for the designated advisory committees are scheduled for
26 repeal on September 1, 2022:

27 (VI) THE COLORADO INTERAGENCY WORKING GROUP ON SCHOOL

1 SAFETY CREATED IN SECTION 24-25-102.

2 **SECTION 3. No appropriation.** The general assembly has
3 determined that this act can be implemented within existing
4 appropriations, and therefore no separate appropriation of state money is
5 necessary to carry out the purposes of this act. ■

6 **SECTION 4. Safety clause.** The general assembly hereby finds,
7 determines, and declares that this act is necessary for the immediate
8 preservation of the public peace, health, or safety.
