A BILL FOR AN ACT CONCERNING THE ENACTMENT OF THE COLORADO REVISED STATUTES 2019 AS THE POSITIVE AND STATUTORY LAW OF THE STATE OF

Bill Summary

Committee on Legal Services. The bill enacts the softbound volumes of the Colorado Revised Statutes 2019 as the positive and statutory law of the state of Colorado and establishes the effective date of said publication.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 2-5-126, add (2)(w) 3 as follows: 4 2-5-126. Annual enactment of Colorado Revised Statutes validation - effective date. (2) The annual statutes, copies of which shall 5 6 be delivered to each member of the general assembly, together with a 7 listing of the revisor's changes, constitute the official report of the 8 committee on legal services and are hereby enacted in accordance with 9 this section as follows: 10 (w) Colorado Revised Statutes 2019. COLORADO REVISED 11 STATUTES 2019, WHICH CONSISTS OF ALL OF THE LAWS OF THE STATE OF 12 COLORADO OF A GENERAL AND PERMANENT NATURE ORIGINALLY 13 ENACTED IN "COLORADO REVISED STATUTES 1973", INCLUDING 14 SUBSEQUENT ENACTMENTS MADE PURSUANT TO SECTION 2-5-125, AND 15 ALL OF THE LAWS OF THE STATE OF COLORADO OF A GENERAL AND 16 PERMANENT NATURE ENACTED AT THE FIRST REGULAR SESSION OF THE 17 SEVENTY-SECOND GENERAL ASSEMBLY AND AS APPROVED BY THE VOTERS 18 AT THE ODD-NUMBERED YEAR STATEWIDE ELECTION ON NOVEMBER 5, 19 2019. THE EFFECTIVE DATE FOR COLORADO REVISED STATUTES 2019 IS 20 FIXED AS THE FIRST DAY THAT IS NOT A SATURDAY, SUNDAY, OR LEGAL 21 HOLIDAY FOLLOWING THE EFFECTIVE DATE OF THIS SUBSECTION (2)(w). 22 **SECTION 2. Safety clause.** The general assembly hereby finds, 23 determines, and declares that this act is necessary for the immediate 24 preservation of the public peace, health, or safety.
