Bill Summary

The bill requires the department of labor and employment to collaborate with the department of education to include in the Colorado state apprenticeship resource directory the name and contact information for at least one designated apprenticeship training program contact for every public high school and school district.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 8-83-308, **add** (1.5)
3 as follows:

4 **8-83-308. Colorado state apprenticeship resource directory -**
5 **collection of apprenticeship program information - promotion of**

6 **public awareness - definitions.** (1.5) (a) ON OR BEFORE JANUARY 1,
7 2021, THE DEPARTMENT SHALL INCLUDE IN THE DIRECTORY THE NAME
8 AND CONTACT INFORMATION FOR AT LEAST ONE DESIGNATED
9 APPRENTICESHIP TRAINING PROGRAM CONTACT FOR EVERY SCHOOL
10 DISTRICT AND PUBLIC HIGH SCHOOL. THE CONTACT INFORMATION MUST
11 INCLUDE, AT A MINIMUM, THE CONTACT'S MAILING ADDRESS, E-MAIL
12 ADDRESS, TELEPHONE NUMBER, AND HIGH SCHOOL OR SCHOOL DISTRICT
13 THAT THE CONTACT REPRESENTS.

14 (b) THE DEPARTMENT SHALL COOPERATE WITH THE DEPARTMENT
15 OF EDUCATION, CREATED AND EXISTING PURSUANT TO SECTION 24-1-115,
16 TO RECEIVE AND ANNUALLY UPDATE THE INFORMATION REQUIRED
17 PURSUANT TO SUBSECTION (1.5)(a) OF THIS SECTION NO LATER THAN
18 SEPTEMBER 1 OF EACH YEAR.

19 (c) AS USED IN THIS SUBSECTION (1.5), UNLESS THE CONTEXT
20 OTHERWISE REQUIRES:

21 (I) "DESIGNATED APPRENTICESHIP TRAINING PROGRAM CONTACT"
22 MEANS A DESIGNEE OF A SCHOOL DISTRICT OR PUBLIC HIGH SCHOOL THAT
23 IS THE PREFERRED POINT OF CONTACT FOR STUDENTS, PARENTS, OR
24 APPRENTICESHIP PROGRAMS TO INTERFACE WITH THE SCHOOL DISTRICTS
25 AND HIGH SCHOOLS ON MATTERS RELATED TO APPRENTICESHIP TRAINING
26 OPPORTUNITIES AND WORKFORCE TRAINING.

1 (II) "PUBLIC HIGH SCHOOL" MEANS A PUBLIC SCHOOL AS DEFINED
2 IN SECTION 22-1-101, INCLUDING A DISTRICT CHARTER SCHOOL OR AN
3 INSTITUTE CHARTER SCHOOL THAT COVERS ANY GRADE FROM NINTH
4 THROUGH TWELFTH.

5 (III) "SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT AUTHORIZED
6 BY SECTION 15 OF ARTICLE IX OF THE STATE CONSTITUTION AND
7 ORGANIZED PURSUANT TO ARTICLE 30 OF TITLE 22. "SCHOOL DISTRICT"
8 ALSO INCLUDES A BOARD OF COOPERATIVE SERVICES CREATED PURSUANT
9 TO ARTICLE 5 OF TITLE 22 IF IT IS OPERATING A PUBLIC HIGH SCHOOL.

10 **SECTION 2. Act subject to petition - effective date.** This act
11 takes effect at 12:01 a.m. on the day following the expiration of the
12 ninety-day period after final adjournment of the general assembly (August
13 5, 2020, if adjournment sine die is on May 6, 2020); except that, if a
14 referendum petition is filed pursuant to section 1 (3) of article V of the
15 state constitution against this act or an item, section, or part of this act
16 within such period, then the act, item, section, or part will not take effect
17 unless approved by the people at the general election to be held in
18 November 2020 and, in such case, will take effect on the date of the
19 official declaration of the vote thereon by the governor.
