The bill adds 2 voting positions to the Colorado youth advisory council for representatives from the Southern Ute tribe and the Ute Mountain Ute tribe.

2 **SECTION 1.** In Colorado Revised Statutes, 2-2-1303, **amend**
3 (1)(b) introductory portion and (1)(b)(II) as follows:

4 **2-2-1303. Membership - selection - terms.** (1) The council
5 consists of forty-four members as follows:

6 (b) Thirty-five voting members representing each senate district
7 in the state, ~~and five~~ ONE VOTING MEMBER REPRESENTING THE SOUTHERN
8 UTE INDIAN TRIBE, ONE VOTING MEMBER REPRESENTING THE UTE
9 MOUNTAIN UTE TRIBE, AND THREE NONVOTING at-large members. The
10 ~~five~~ THREE at-large members must be selected to help ensure diversity on
11 the council, with an express concern for adequate rural representation.
12 Members described in this ~~paragraph (b)~~ SUBSECTION (1)(b) must meet
13 the following qualifications at the time of appointment:

14 (II) Be enrolled in and attending a TRIBAL OR Colorado junior
15 high, middle, or high school, including an online or charter school or
16 approved facility school as defined in section 22-2-402; ~~C.R.S.~~; be
17 participating in a nonpublic, home-based educational program; be
18 participating in a high school equivalency examination program; or have
19 obtained a high school diploma through successful completion of a high
20 school equivalency examination, as defined in section 22-33-102 (8.5).

22 **SECTION 2. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, or safety.
