**Sunset Process - House Public Health Care and Human Services Committee.** The bill implements the recommendation of the department of regulatory agencies' sunset review and report on the nurse-physician advisory task force for Colorado health care (NPATCH) by continuing the NPATCH indefinitely.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (11)  
3 as follows:

4 **2-3-1203. Sunset review of advisory committees - legislative**  
5 **declaration - definition - repeal.** (11) (a) ~~The following statutory~~  
6 ~~authorizations for the designated advisory committees will repeal on~~  
7 ~~September 1, 2020:~~

8 (1) ~~The nurse-physician advisory task force for Colorado health~~  
9 ~~care created in section 12-30-105:~~

10 (b) ~~This subsection (11) is repealed, effective September 1, 2022.~~

11 **SECTION 2.** In Colorado Revised Statutes, 12-30-105, **amend**  
12 (2)(a)(III)(B); and **repeal** (7) as follows:

13 **12-30-105. Nurse-physician advisory task force for Colorado**  
14 **health care - creation - duties - definition.** (2) (a) The NPATCH  
15 consists of twelve members appointed as follows:

16 (III) Ten members appointed by the governor as follows:

17 (B) Three **members** LICENSED PHYSICIANS recommended by and  
18 representing a statewide physicians' organization THAT REPRESENTS  
19 MULTI-SPECIALTY PHYSICIANS AND WHOSE MEMBERSHIP INCLUDES AT  
20 LEAST ONE-THIRD OF THE DOCTORS OF MEDICINE AND OSTEOPATHY  
21 LICENSED IN THE STATE;

22 (7) ~~This section is repealed, effective September 1, 2020. Before~~

1 ~~the repeal, the functions of the NPATCH are scheduled for review in~~  
2 ~~accordance with section 2-3-1203.~~

3 **SECTION 3. Appropriation.** For the 2020-21 state fiscal year,  
4 \$15,554 is appropriated to the department of regulatory agencies for use  
5 by the division of professions and occupations. This appropriation is from  
6 the division of professions and occupations cash fund created in section  
7 12-20-105 (3), C.R.S., and is based on an assumption that the division  
8 will require an additional 0.2 FTE. To implement this act, the division  
9 may use this appropriation for personal services.

10 **SECTION 4. Act subject to petition - effective date.** This act  
11 takes effect at 12:01 a.m. on the day following the expiration of the  
12 ninety-day period after final adjournment of the general assembly (August  
13 5, 2020, if adjournment sine die is on May 6, 2020); except that, if a  
14 referendum petition is filed pursuant to section 1 (3) of article V of the  
15 state constitution against this act or an item, section, or part of this act  
16 within such period, then the act, item, section, or part will not take effect  
17 unless approved by the people at the general election to be held in  
18 November 2020 and, in such case, will take effect on the date of the  
19 official declaration of the vote thereon by the governor.
