department of regulatory agencies' sunset review and report on the regulation of naturopathic doctors by:

- ! Continuing the regulation of naturopathic doctors for 9 years, to 2029 (sections 1 and 2 of the bill);
- Providing immunity from liability for the director of the division of professions and occupations, division staff, consultants, and complainants in any civil action brought against the individual for acts occurring while the individual is acting in the individual's capacity as director, board member, staff, consultant, or witness, respectively (section 3);
- ! Removing references to the North American Board of Naturopathic Examiners and the Council on Naturopathic Medical Education (sections 4 and 6); and
- ! Repealing the requirement that a naturopathic doctor develop and execute a collaborative agreement with a licensed physician before the naturopathic doctor can treat children under the age of 2 (sections 5 and 7).

13	prescribing, as specified, medicines listed in the naturopathic formulary,
14	which includes:
15	(A) Obtaining, administering, or dispensing Epinephrine to treat
16	anaphylaxis;
17	(B) Obtaining and dispensing Barrier contraceptives, excluding
18	intrauterine devices;
19	(C) Obtaining and administering Oxygen, but only for emergency
20	use;
21	(D) Obtaining and administering Vitamins B6 and B12;
22	(E) Obtaining, administering, or dispensing Substances that are
23	regulated by the federal food and drug administration but that do not
24	require a prescription order to be dispensed; and
25	(F) Obtaining and administering Vaccines, in accordance with the
26	ACIP guidelines, for patients who are at least eighteen years of age; AND
27	(G) ANY ADDITIONS TO THE NATUROPATHIC FORMULARY AS

1	DETERMINED BY THE DIRECTOR BY RULE, LIMITED TO BIOLOGICAL
2	SUBSTANCES INCLUDING VITAMINS, MINERALS, NUTRITIVE SUBSTANCES,

4	(5) Except as provided in subsection (4) of this section, a person
5	who is not registered under this article 250 shall not:
6	(c) Use the title "naturopathic doctor", or "doctor of naturopathy",
7	or the abbreviation "N.D.", OR ANY OTHER TITLE THAT IMPLIES THE
8	PERSON IS REGISTERED OR LICENSED AS A NATUROPATHIC DOCTOR.
9	SECTION 6. Safety clause. The general assembly hereby finds,
10	determines, and declares that this act is necessary for the immediate
11	preservation of the public peace, health, or safety.
