2 **services for the fiscal year beginning July 1, 2019.** In Session Laws of
3 Colorado 2019, **add a new appropriation** as section 6 to chapter 257,
4 (SB 19-258), as follows:

5 Section 6. **Appropriation.** For the 2019-20 state fiscal year,
6 \$2,370,740 is appropriated to the department of human services for use
7 by the division of child welfare. This appropriation is from the Title IV-E
8 administrative cost cash fund created in section 26-2-102.5 (3)(b)(I),
9 C.R.S. To implement this act, the division may use this appropriation for

11 **SECTION 3. Appropriation to the department of human**
12 **services for the fiscal year beginning July 1, 2019.** In Session Laws of
