Bill Summary

The bill aligns the requirements for a minor to obtain a new birth certificate from the state registrar with the requirements for an adult. A minor shall also obtain a statement from a medical or mental health professional confirming that the minor's sex designation does not align with the minor's gender identity.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25-2-113.8, **amend**
3 (3)(b)(II) and (9) as follows:

4 **25-2-113.8. Birth certificate modernization act - new birth**
5 **certificate following a change in gender designation - short title.**

6 (3) The state registrar shall issue a new birth certificate to a person who
7 was born in this state and who has a gender different from the sex
8 denoted on that person's birth certificate when the state registrar receives:

9 (b) (II) If the person is a minor under the age of eighteen, a
10 statement, in a form or format designated by the state registrar, signed
11 under penalty of law, from a professional medical or mental health care
12 provider licensed in good standing in Colorado or with an equivalent
13 license in good standing from another jurisdiction, stating ~~that:~~ THE SEX
14 DESIGNATION ON THE BIRTH CERTIFICATE DOES NOT ALIGN WITH THE
15 MINOR'S GENDER IDENTITY. THIS SUBSECTION (3)(b)(II) DOES NOT
16 REQUIRE A MINOR TO UNDERGO ANY SPECIFIC SURGERY, TREATMENT,
17 CLINICAL CARE, OR BEHAVIORAL HEALTH CARE.

4 25-2-115 (1), the new birth certificate supersedes the original as the
5 official public record and must not be marked as amended or indicate in
6 any other manner that the gender designation or name on the certificate
7 has been changed.

17 WHEN THE DEPARTMENT RECEIVES:

18 (A) A statement, in a form or format designated by the
19 department, from the person, or from the person's parent if the person is
20 a minor, or from the person's guardian or legal representative, signed

15 (2.5) (a) The department shall issue a new identification card to a person
16 who has a gender different from the sex denoted on that person's
17 identification card when the department receives A NEW BIRTH
18 CERTIFICATE ISSUED PURSUANT TO SECTION 25-2-113.8 OR WHEN THE
19 DEPARTMENT RECEIVES:

20 (I) (A) A statement, in a form or format designated by the
21 department, from the person, or from the person's parent if the person is
22 a minor, or from the person's guardian or legal representative, signed
23 under penalty of law, confirming the sex designation on the person's
24 identification card does not align with the person's gender identity; and
