The voluntary contributions to the American Red Cross Colorado disaster response, readiness, and preparedness fund, Colorado domestic abuse program fund, Habitat for Humanity of Colorado fund, pet overpopulation fund, and Special Olympics Colorado fund are currently scheduled to appear on the state income tax return form for income tax

years beginning prior to January 1, 2020. The contributions are set to repeal unless they are continued. The bill reauthorizes the funds to remain on the form so long as they meet the existing statutory requirement that a voluntary contribution fund must receive at least \$50,000 in contributions each tax year.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 39-22-1001, **amend**

11 ~~this article 22.~~ All other voluntary contribution programs shall remain on
12 Colorado income tax returns for the income tax years specified in the part
13 in which the voluntary contribution is established and shall be repealed
14 or reestablished as directed in such part; EXCEPT THAT, THERE SHALL BE
15 NO REQUIREMENT FOR A SUNSET CLAUSE FOR:

11 **SECTION 2.** In Colorado Revised Statutes, **amend** 39-22-801 as

4 Habitat for Humanity of Colorado fund voluntary contribution is next in
5 the queue established pursuant to said section 39-22-1001 (8); FOR
6 INCOME TAX YEARS COMMENCING ON OR AFTER JANUARY 1, 2019, the
7 Colorado state individual income tax return form shall MUST contain a
8 line whereby each individual taxpayer may designate the amount of the
9 contribution, if any, the individual TAXPAYER wishes to make to the
10 Habitat for Humanity of Colorado fund created in section 39-22-4503 (1).

11 **SECTION 11.** In Colorado Revised Statutes, **amend** 39-22-4504
12 as follows:

13 **39-22-4504. Repeal of part.** This part 45 is repealed, effective
14 January 1 of the sixth income tax year following the year in which the
15 executive director files written certification with the revisor of statutes as
16 specified in section 39-22-1001 (8) that a line has become available and
17 THAT the Habitat for Humanity of Colorado fund voluntary contribution
18 is next in the queue, unless the Habitat for Humanity of Colorado fund
19 established by this part 45 is continued or reestablished by the general
20 assembly acting by bill prior to said date WILL NO LONGER APPEAR ON THE
21 INDIVIDUAL INCOME TAX RETURN FORM DUE TO A FAILURE TO MEET THE
22 REQUIREMENTS OF SECTION 39-22-1001 (5)(a).

23 **SECTION 12. Act subject to petition - effective date.** This act
24 takes effect at 12:01 a.m. on the day following the expiration of the
25 ninety-day period after final adjournment of the general assembly; except
26 that, if a referendum petition is filed pursuant to section 1 (3) of article V
27 of the state constitution against this act or an item, section, or part of this

1 act within such period, then the act, item, section, or part will not take
2 effect unless approved by the people at the general election to be held in
3 November 2022 and, in such case, will take effect on the date of the
4 official declaration of the vote thereon by the governor.
