This bill increases access to multilingual ballots for voters and requires additional translation services to be offered by the Department of State. The bill increases state and local expenditures on an ongoing basis.

**Appropriation Summary:** For FY 2020-21, the bill requires an appropriation of \$83,862 to the Department of State.

**Fiscal Note Status:** This fiscal note reflects the introduced bill.

## Summary of Legislation

The bill requires the Department of State (department) to establish a multilingual ballot hotline to provide access to qualified translators in each of the languages offered in the most recent decennial census, to assist electors in translating ballot language. The service must be established for the general election held in November 2020, and for every general and statewide odd-year election that follows.

The bill also requires the department and county clerks to coordinate in offering a minority language sample ballot and an in-person ballot (when requested) for counties where:

- at least 2,000 citizens, ages 18 and up, speak English less than very well, as defined by the American Community Survey, and speak a shared minority language at home; or
- at least 2.5 percent of citizens, ages 18 and up, speak English less than very well, and speak a shared minority language at home.

The minority language ballots must be available for the general election held in November 2020, and for every general and statewide odd-year election that follows.

## Assumptions

This fiscal note assumes that the department will have to contract with a third-party to provide qualified translators for the multilingual ballot hotline and will offer the 12 spoken languages offered on the 2020 census. It is assumed that the qualified translators will cost \$2.35 per minute, with an average call length of 20 minutes. Approximately 250 voters are expected to utilize this service each year. These assumptions are based on pricing provided by third-parties and on the experience of the City and County of Denver, which utilized a similar service during the 2018 general election.

This note assumes that for the general election in 2020 the department will have to provide a minority language ballot to 22 counties in both Spanish and Vietnamese. The department currently translates the state-wide ballot into Spanish, and it is assumed that it will cost \$432 to translate the statewide ballot into Vietnamese. This cost is based on informal quotations from several third-party vendors. The department is assumed to only provide translation services for the state-wide ballot.

## State Expenditures

The bill increases cash fund expenditures in the Department of State by \$83,862 in FY 2020-21, and by \$12,182 in FY 2021-22 and in future years.

The Department of State will incur a one-time programming cost of \$71,680 in FY 2020-21 to make system changes to the Ballot Access application to include new languages and additional content. Programming costs assume 640 hours at a rate of \$112 per hour. The Department of State will also incur ongoing costs of \$12,182 per year beginning in FY 2020-21 to provide qualified translators for the multilingual ballot hotline (\$11,750), and to translate statewide ballot content into Vietnamese (\$432).

## Local Government

The bill requires county clerks to provide translations of all county and local level ballot content if a minority language ballot is required in their county. The total cost for counties will depend on the number of minority languages each county is required to accommodate, the amount of ballot content that must be translated, the number of different ballot layouts, and management costs to administer the new multilingual ballots. The annual cost to county clerks could range from roughly \$45,000 for a small county, \$60,000 for a medium county, and over \$350,000 for a large county.

## Effective Date

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

## State Appropriations

For FY 2020-21, this bill requires an appropriation of \$83,862 from the Department of State Cash Fund to the Department of State.
