**Sunset Process - Senate Education Committee.** The bill continues the council of higher education representatives (council) indefinitely by removing the repeal of the council.

1           **SECTION 1.** In Colorado Revised Statutes, 23-1-108.5, amend  
2 (3)(e) as follows:

3           **23-1-108.5. Duties and powers of the commission with regard**  
4 **to common course numbering system - definitions - repeal.**

5 (3) (e) This subsection (3) is repealed, effective September 1, 2021. Prior  
6 to such 2031. BEFORE THE repeal, the council of higher education  
7 representatives shall be reviewed as provided for IS SCHEDULED FOR  
8 REVIEW in ACCORDANCE WITH section 2-3-1203. C.R.S.

9           **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
10 **(12)(a)(V); and add (22)** as follows:

11           **2-3-1203. Sunset review of advisory committees - legislative**  
12 **declaration - definition - repeal.** (12) (a) The following statutory  
13 authorizations for the designated advisory committees will repeal on  
14 September 1, 2021:

15           (V) ~~The council of higher education representatives convened~~  
16 ~~pursuant to section 23-1-108.5 (3), C.R.S.;~~

17           (22) (a) THE FOLLOWING STATUTORY AUTHORIZATIONS FOR THE  
18 DESIGNATED ADVISORY COMMITTEES WILL REPEAL ON SEPTEMBER 1,  
19 2031:

20           (I) THE COUNCIL OF HIGHER EDUCATION REPRESENTATIVES  
21 CONVENED PURSUANT TO SECTION 23-1-108.5 (3).

22           (b) THIS SUBSECTION (22) IS REPEALED, EFFECTIVE SEPTEMBER 1,  
23 2033.

24           **SECTION 3. Effective date.** This act takes effect September 1,  
25 2021.

26           **SECTION 4. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, or safety.
