**A BILL FOR AN ACT**

101      **CONCERNING EXPANSION OF THE PRESCRIPTION DRUG MONITORING**  
102              **PROGRAM TO TRACK INFORMATION REGARDING ALL**  
103              **PRESCRIPTION DRUGS PRESCRIBED IN COLORADO, AND, IN**  
104              **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

Current law requires the prescription drug monitoring program (program) to track all controlled substances prescribed in Colorado. The bill expands the program, effective February 1, 2023, to track all

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-280-404, **amend**  
3 **(2) as follows:**

4 **12-280-404. Program operation - access - rules - definitions -**  
5 **repeal.** (2) (a) **The board shall adopt all rules necessary to implement the**  
6 **program.**

7 **(b) THE BOARD SHALL DETERMINE IF THE PROGRAM SHOULD**  
8 **TRACK ALL PRESCRIPTION DRUGS PRESCRIBED IN THIS STATE. IF THE**  
9 **BOARD MAKES SUCH DETERMINATION, THE BOARD SHALL PROMULGATE**  
10 **RULES ON OR BEFORE JUNE 1, 2022, TO INCLUDE ALL PRESCRIPTION DRUGS**  
11 **IN THE PROGRAM. IF THE BOARD DETERMINES THAT ONE OR MORE**  
12 **PRESCRIPTION DRUGS SHOULD NOT BE TRACKED THROUGH THE PROGRAM,**  
13 **THE BOARD SHALL PUBLICLY NOTE THE JUSTIFICATION FOR SUCH**  
14 **EXCLUSION DURING THE RULE-MAKING PROCESS.**

15 **SECTION 2. Appropriation.** (1) **For the 2021-22 state fiscal**  
16 **year, \$61,118 is appropriated to the department of regulatory agencies for**  
17 **use by the division of professions and occupations. This appropriation is**  
18 **from the prescription drug monitoring fund created in section 12-280-405**  
19 **(1), C.R.S. To implement this act, the division may use this appropriation**  
20 **as follows:**

21 **(a) \$53,838 for personal services, which amount is based on an**  
22 **assumption that the division will require an additional 0.8 FTE; and**

23 **(b) \$7,280 for operating expenses."**

24 **SECTION 3. Act subject to petition - effective date.** This act  
25 **takes effect at 12:01 a.m. on the day following the expiration of the**

1 ninety-day period after final adjournment of the general assembly; except  
2 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
3 of the state constitution against this act or an item, section, or part of this  
4 act within such period, then the act, item, section, or part will not take  
5 effect unless approved by the people at the general election to be held in  
6 November 2022 and, in such case, will take effect on the date of the  
7 official declaration of the vote thereon by the governor.
