Bill Summary

Current law requires the prescription drug monitoring program (program) to track all controlled substances prescribed in Colorado. The bill expands the program, effective February 1, 2023, to track all

prescription drugs prescribed in this state. The bill extends the repeal of the program until September 1, 2028.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, 12-280-404, amend
3	(2) as follows:
4	<u> 12-280-404. Program operation - access - rules - definitions -</u>
5	repeal. (2) (a) The board shall adopt all rules necessary to implement the
6	<u>program.</u>
7	(b) The board shall determine if the program should

15	SECTION 2. Appropriation. (1) For the 2021-22 state fiscal
16	year, \$61,118 is appropriated to the department of regulatory agencies for
17	use by the division of professions and occupations. This appropriation is
18	from the prescription drug monitoring fund created in section 12-280-405
19	(1), C.R.S. To implement this act, the division may use this appropriation
20	<u>as follows:</u>
21	(a) \$53,838 for personal services, which amount is based on an
22	assumption that the division will require an additional 0.8 FTE; and
23	(b) \$7,280 for operating expenses.".
24	SECTION 3. Act subject to petition - effective date. This act
