A BILL FOR AN ACT

101 **CONCERNING REQUIREMENTS OF PET STORES THAT SELL CERTAIN PET**
102 **ANIMALS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates the "Pet Store Consumer Protection Act", which prohibits a pet store that was not licensed by the commissioner of agriculture prior to the effective date of the bill from selling or offering to sell dogs or cats on or after the effective date of the bill.

The bill also requires each pet store licensed to sell or offer to sell dogs or cats that continues to sell or offer to sell dogs or cats to:

- Include on all advertisements, including website postings, the purchase price of the dog or cat and any applicable federal or state license numbers for the breeder of the dog or cat;
- Post on the enclosure of each dog or cat the purchase price of the dog or cat and certain information on the dog's or cat's breeder; and
- Make certain written disclosures to a prospective consumer prior to selling a dog or cat.

3 **SECTION 1.** In Colorado Revised Statutes, 35-80-102, **add** (9.3),
4 (11.3), and (11.7) as follows:

5 **35-80-102. Definitions.** As used in this article 80, unless the
6 context otherwise requires:

7 (9.3) (a) "OFFER FOR SALE" MEANS TO ADVERTISE A POTENTIAL
8 SALE BY A PET STORE.

9 (b) "OFFER FOR SALE" INCLUDES:

10 (I) THE DISPLAY OF A LIVE DOG OR CAT FOR SALE; AND

11 (II) A VERBAL OR WRITTEN OFFER TO SELL A DOG OR CAT.

12 (11.3) "PET STORE" MEANS A RETAIL ESTABLISHMENT WHERE PET
13 ANIMALS ARE SOLD OR OFFERED FOR SALE TO THE GENERAL PUBLIC. "PET
14 STORE" DOES NOT INCLUDE AN ANIMAL SHELTER, PET ANIMAL RESCUE, CAT
15 BREEDER, OR DOG BREEDER.

16 (11.7) "SALE" OR "SELL" MEANS THE EXCHANGE OF A PET ANIMAL
17 FOR ANYTHING OF VALUE, INCLUDING PROPERTY OR MONEY. "SALE" OR
18 "SELL" DOES NOT INCLUDE AN ADOPTION TRANSACTION BETWEEN AN
19 ANIMAL SHELTER OR PET ANIMAL RESCUE AND A PERSON WHO ADOPTS A
20 PET ANIMAL.

1 **SECTION 2.** In Colorado Revised Statutes, **add 35-80-108.5** as
2 follows:

3 **35-80-108.5. Dog breeders and cat breeders - pet stores -**
4 **prohibited sales and purchases of dogs or cats - short title.** (1) THE
5 SHORT TITLE OF THIS SECTION IS THE "PET STORE CONSUMER PROTECTION
6 ACT".

7 (2) ON AND AFTER THE EFFECTIVE DATE OF THIS SECTION, A PET
8 STORE THAT:

9 (a) EXISTED PRIOR TO THE EFFECTIVE DATE OF THIS SECTION, BUT
10 WAS NOT LICENSED BY THE COMMISSIONER PRIOR TO THE EFFECTIVE DATE
11 OF THIS SECTION TO SELL OR OFFER FOR SALE DOGS OR CATS, SHALL NOT
12 SELL OR OFFER FOR SALE DOGS OR CATS; OR

13 (b) DID NOT EXIST PRIOR TO THE EFFECTIVE DATE OF THIS SECTION
14 SHALL NOT SELL OR OFFER FOR SALE DOGS OR CATS.

15 (3) (a) A PET STORE THAT WAS LICENSED BY THE COMMISSIONER
16 PRIOR TO THE EFFECTIVE DATE OF THIS SECTION TO SELL OR OFFER FOR
17 SALE DOGS OR CATS MAY CONTINUE TO SELL OR OFFER FOR SALE DOGS OR
18 CATS ON OR AFTER THE EFFECTIVE DATE OF THIS SECTION:

19 (I) FROM THE SAME LOCATION, WHETHER UNDER THE CURRENT
20 OWNER OR UNDER CHANGED OWNERSHIP; OR

21 (II) FROM A NEW LOCATION THAT REPLACES THE EXISTING
22 LOCATION, WHETHER UNDER THE CURRENT OWNER OR UNDER CHANGED
23 OWNERSHIP.

24 (b) THE PET STORE SHALL:

25 (I) INCLUDE ON ALL ADVERTISEMENTS, INCLUDING WEBSITE
26 POSTINGS, THE PURCHASE PRICE OF THE DOG OR CAT AND ANY APPLICABLE
27 FEDERAL OR STATE LICENSE NUMBERS FOR THE BREEDER OF THE DOG OR

1 CAT;

2 (II) POST ON THE ENCLOSURE OF EACH DOG OR CAT THE PURCHASE
3 PRICE OF THE DOG OR CAT AND THE FOLLOWING INFORMATION ON THE
4 DOG'S OR CAT'S BREEDER: FULL NAME; KENNEL NAME, IF APPLICABLE;
5 CITY; STATE; AND ANY APPLICABLE STATE OR FEDERAL LICENSE NUMBERS;
6 AND

7 (III) DISCLOSE TO A PROSPECTIVE CONSUMER IN WRITING, PRIOR
8 TO THE SALE OF A DOG OR CAT, THE FOLLOWING INFORMATION ABOUT THE
9 DOG OR CAT:

10 (A) THE PURCHASE PRICE OF THE DOG OR CAT;

11 (B) THE INTEREST RATE OR RANGE ASSOCIATED WITH ANY
12 FINANCING OR CREDIT CARD OFFERED TO THE PROSPECTIVE PURCHASER;
13 AND

14 (C) ANY APPLICABLE FEDERAL OR STATE LICENSE NUMBERS AND
15 AN UNREDACTED LIST OF ALL VIOLATIONS OF ANY FEDERAL OR STATE LAW
16 THE DOG OR CAT BREEDER, BROKER, OR TRANSPORTER RECEIVED IN THE
17 PREVIOUS TWO YEARS ON A FEDERAL OR STATE INSPECTION REPORT.

18 (4) ON AND AFTER THE EFFECTIVE DATE OF THIS SECTION, THE
19 NUMBER OF PET STORES AUTHORIZED TO SELL OR OFFER FOR SALE DOGS OR
20 CATS MUST NOT EXCEED THE NUMBER OF PET STORES THAT WERE
21 AUTHORIZED TO SELL OR OFFER FOR SALE DOGS OR CATS ON THE DAY
22 BEFORE THE EFFECTIVE DATE OF THIS SECTION.

23 (5) NOTHING IN THIS SECTION PRECLUDES A STATUTORY OR HOME
24 RULE TOWN, CITY, COUNTY, OR CITY AND COUNTY FROM ENACTING LAWS
25 MORE STRINGENT THAN THE REQUIREMENTS OF THIS SECTION, INCLUDING
26 A PROHIBITION ON THE SALE OR OFFER FOR SALE OF DOGS AND CATS.

1 **SECTION 3. Act subject to petition - effective date -**
2 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
3 the expiration of the ninety-day period after final adjournment of the
4 general assembly; except that, if a referendum petition is filed pursuant
5 to section 1 (3) of article V of the state constitution against this act or an
6 item, section, or part of this act within such period, then the act, item,
7 section, or part will not take effect unless approved by the people at the
8 general election to be held in November 2022 and, in such case, will take
9 effect on the date of the official declaration of the vote thereon by the
10 **governor.**
11 (2) This act applies to conduct occurring on or after the applicable
12 **effective date of this act.**
