A BILL FOR AN ACT

101 **CONCERNING THE REGULATION OF MEMBERS OF BOARDS OF HEALTH,**
102 **AND, IN CONNECTION THEREWITH, REGULATING THE MEMBERS**
103 **OF STATE, COUNTY, AND DISTRICT BOARDS OF HEALTH.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill specifies that members of a county or district board of health are not allowed to serve concurrently as members of a board of county commissioners and as members of a county or district board of health. The bill also allows members of a county or district board of health to be removed for malfeasance or other specified reasons.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25-1-508, **add** (7),
3 (8), and (9) as follows:

4 **25-1-508. County or district boards of public health - public**
5 **health directors.** (7) MEMBERS OF A COUNTY BOARD OF HEALTH OR A
6 DISTRICT BOARD OF HEALTH, ALONG WITH THE MEMBERS OF THE STATE
7 BOARD OF HEALTH, SHALL ATTEND ANNUAL PUBLIC HEALTH TRAINING,
8 DEVELOPED AND PROVIDED BY THE DEPARTMENT OF PUBLIC HEALTH AND
9 ENVIRONMENT AND THE DIRECTOR OF THE OFFICE OF EMERGENCY
10 MANAGEMENT CREATED IN SECTION 24-33.5-705, CONCERNING THE ROLE
11 OF A BOARD OF HEALTH IN PREPARING FOR, RESPONDING TO, AND
12 RECOVERING FROM AN EMERGENCY DISASTER.

13 (8) THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT
14 SHALL PROVIDE GUIDANCE ON RECRUITING PERSONS WHO ARE ELIGIBLE
15 AND WILLING TO SERVE ON COUNTY AND DISTRICT BOARDS OF HEALTH.
16 THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT SHALL PROVIDE
17 THE GUIDANCE IN AN ELECTRONIC FORMAT TO ANY BOARD OF COUNTY
18 COMMISSIONERS, COUNTY BOARD OF HEALTH, OR DISTRICT BOARD OF
19 HEALTH THAT REQUESTS IT.

20 (9) CHANGES TO THIS SECTION MADE BY HOUSE BILL 21-1115,
21 ENACTED IN 2021, TAKE EFFECT JANUARY 1, 2022.

22 **SECTION 2. Act subject to petition - effective date.** This act
23 takes effect at 12:01 a.m. on the day following the expiration of the
24 ninety-day period after final adjournment of the general assembly; except
25 that, if a referendum petition is filed pursuant to section 1 (3) of article V
26 of the state constitution against this act or an item, section, or part of this

1 act within such period, then the act, item, section, or part will not take
2 effect unless approved by the people at the general election to be held in
3 November 2022 and, in such case, will take effect on the date of the
4 official declaration of the vote thereon by the governor.
