**A BILL FOR AN ACT**

101 **CONCERNING THE CREATION OF A VOLUNTARY SOIL HEALTH**  
102 **PROGRAM.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates the Colorado soil health program in the department of agriculture (department). The soil health program is voluntary. The department, commissioner of agriculture (commissioner), and state agricultural commission will administer the soil health program.

The department may establish the following:

- A system for monitoring the environmental or economic

- benefits of soil health practices;
- A state soil health inventory and platform;
- A soil health testing program; and
- Other programs the department deems appropriate or necessary.

Before establishing a system, inventory and platform, or program, the department must provide public notice and afford the public an opportunity to submit written comments.

The department may also:

- Seek, accept, and expend gifts, grants, or donations;
- Administer and expend the money from public and private sources;
- Provide grants, loans, and other resources to perform soil health activities; and
- Cooperate and collaborate with other people.

The bill also creates a soil health advisory committee (advisory committee). The commissioner is required to appoint members who represent the different geographic areas, political diversity, and demographic diversity of the state and include agricultural producers of diverse production systems.

The advisory committee will make recommendations to the department and assist in the development of the soil health program. The advisory committee is also authorized to solicit input, review proposals and agreements, and evaluate the soil health program.

The department shall maintain the confidentiality of information related to private lands that identify landowners, land managers, agricultural producers, or lands.

No later than January 31 of each year, the department shall prepare and make available to the public a report of its activities on its official website.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1. Legislative declaration.** (1) The general assembly  
3 hereby finds and declares that:

4           (a) Conserving and enhancing Colorado's agricultural soils is  
5 critical to maintaining and increasing the economic and environmental  
6 sustainability and vitality of agriculture;

7           (b) Healthy soils can increase agricultural producer profitability  
8 by reducing labor and supply costs and increasing yields and resilience to

1 extreme weather events, including drought and heat;

2 (c) Healthy soils support rural communities by increasing the  
3 prosperity of farming and ranching families and supporting closely tied  
4 local food and agricultural businesses;

5 (d) Healthy soils have important environmental benefits, including  
6 improved air and water quality, soil structural integrity, erosion  
7 prevention, and nutrient cycling; increased biological and microbiological  
8 diversity; and carbon sequestration; and

9 (e) Colorado has a robust legacy of soil and environmental  
10 stewardship, and the state conservation board and conservation districts  
11 have led agricultural conservation efforts for decades.

13 **SECTION 2.** In Colorado Revised Statutes, **add** article 73 to title  
14 35 as follows:

#### **Voluntary Soil Health Program**

**35-73-101. Short title.** THE SHORT TITLE OF THIS ARTICLE 73 IS  
18 THE "VOLUNTARY SOIL HEALTH PROGRAM ACT".

19

**35-73-102. Definitions.** AS USED IN THIS ARTICLE 73, UNLESS THE  
20 CONTEXT OTHERWISE REQUIRES:

21

(1) "ADVISORY COMMITTEE" MEANS THE SOIL HEALTH ADVISORY  
22 COMMITTEE CREATED IN SECTION 35-73-106.

23

(2) "COMMISSIONER" MEANS THE COMMISSIONER OF AGRICULTURE  
24 OR THE COMMISSIONER'S AUTHORIZED AGENT.  
25

26

(3) "DEPARTMENT" MEANS THE DEPARTMENT OF AGRICULTURE  
27 AND INCLUDES THE STATE AGRICULTURAL COMMISSION CREATED IN

1 SECTION 35-1-105, THE COMMISSIONER, AND ALL EMPLOYEES AND AGENTS  
2 OF THE DEPARTMENT.

4 (4) "GRANT PROGRAM" MEANS A GRANT PROGRAM AUTHORIZED  
5 IN SECTION 35-73-104 (1)(a).

7 (5) "PROGRAM" MEANS A COMPONENT, INCLUDING A SYSTEM,  
8 GRANT PROGRAM, OR INVENTORY OR PLATFORM, OF THE SOIL HEALTH  
9 PROGRAM THAT IS AUTHORIZED IN SECTION 35-73-104.

10 (6) "SOIL HEALTH" MEANS THE CONTINUED CAPACITY OF SOIL TO  
11 FUNCTION AS A VITAL LIVING ECOSYSTEM THAT SUSTAINS PLANTS,  
12 ANIMALS, AND HUMANS.

13 (7) "SOIL HEALTH PRACTICES" MEANS THOSE PRACTICES THAT MAY  
14 CONTRIBUTE TO SOIL HEALTH OR APPLY ONE OF THE FOLLOWING  
15 PRINCIPLES THAT PROMOTE SOIL HEALTH:

- 16 (a) MAXIMIZING SOIL COVER;
- 17 (b) REDUCING SOIL DISTURBANCE;
- 18 (c) MAXIMIZING BIODIVERSITY;
- 19 (d) MAINTAINING A CONTINUAL LIVE PLANT OR ROOT IN THE SOIL;

20 OR

21 (e) INTEGRATING BEST GRAZING LIVESTOCK PRACTICES.

22 (8) "SOIL HEALTH PROGRAM" MEANS THE COLORADO SOIL HEALTH  
23 PROGRAM CREATED IN SECTION 35-73-103.

24 (9) "STATE SOIL HEALTH INVENTORY AND PLATFORM" MEANS A  
25 TOOL, INCLUDING A GEOSPATIAL INVENTORY, DOCUMENTING:

- 26 (a) THE CONDITION OF AGRICULTURAL SOILS;
- 27 (b) THE IMPLEMENTATION OF SOIL HEALTH PRACTICES;

1 (c) THE ENVIRONMENTAL AND ECONOMIC EFFECTS, INCLUDING  
2 CURRENT AND POTENTIAL FUTURE CARBON HOLDING CAPACITY OF SOILS;  
3 OR

4 (d) OTHER INFORMATION THAT CONCERNS SOIL HEALTH AND THAT  
5 THE DEPARTMENT DEEMS APPROPRIATE.

7 (10) "UNDERSERVED AGRICULTURAL PRODUCER" MEANS AN  
8 AGRICULTURAL PRODUCER WITH LIMITED RESOURCES, A BEGINNING  
9 PRODUCER, A MILITARY VETERAN AGRICULTURAL PRODUCER WHO WAS  
10 RELEASED UNDER CONDITIONS OTHER THAN DISHONORABLE OR BY A BAD  
11 CONDUCT DISCHARGE, OR OTHER TYPES OF UNDERSERVED AGRICULTURAL  
12 PRODUCERS AS DETERMINED BY THE ADVISORY COMMITTEE.

13 **35-73-103. Colorado soil health program - created - purposes.**  
14 THE COLORADO SOIL HEALTH PROGRAM IS HEREBY ESTABLISHED IN THE  
15 DEPARTMENT TO ENCOURAGE WIDESPREAD ADOPTION OF SOIL HEALTH  
16 PRACTICES BY AGRICULTURAL PRODUCERS, PROMOTE ENVIRONMENTAL  
17 BENEFITS, AND ADVANCE THE UNDERSTANDING OF THE ENVIRONMENTAL  
18 AND ECONOMIC BENEFITS OF SOIL HEALTH PRACTICES.

19 **35-73-104. Program development - programs, grants, systems,**  
20 **and inventories and platforms.** (1) IN CONSULTATION WITH THE  
21 ADVISORY COMMITTEE AND IN ACCORDANCE WITH SUBSECTION (4) OF THIS  
22 SECTION, THE DEPARTMENT SHALL ESTABLISH THE FOLLOWING IF  
23 FINANCIAL RESOURCES ARE AVAILABLE:

24 (a) A GRANT PROGRAM FOR ELIGIBLE ENTITIES TO ENGAGE IN SOIL  
25 HEALTH ACTIVITIES;

26 (b) A SYSTEM FOR MONITORING THE AGRICULTURAL,  
27 ENVIRONMENTAL, OR ECONOMIC BENEFITS OF SOIL HEALTH PRACTICES AS

1 DEMONSTRATED BY IMPLEMENTATION EXPERIENCE, RESEARCH PROJECTS,  
2 DEMONSTRATION PROJECTS, OR SOIL HEALTH ACTIVITIES;

3 (c) A STATE SOIL HEALTH INVENTORY AND PLATFORM;

4 (d) A SOIL HEALTH TESTING PROGRAM; AND

5 (e) OTHER PROGRAMS THE DEPARTMENT DEEMS APPROPRIATE OR  
6 NECESSARY TO PROMOTE SOIL HEALTH PRACTICES.

7 (2) (a) IN ESTABLISHING PROGRAMS IN ACCORDANCE WITH  
8 SUBSECTION (1) OF THIS SECTION, THE DEPARTMENT MAY PRIORITIZE THE  
9 ESTABLISHMENT OF PROGRAMS BASED ON ITS DETERMINATION OF  
10 AGRICULTURAL PRODUCER NEED AND SUPPORT, THE AVAILABILITY OF  
11 MONEY AND STAFFING, EMERGING AREAS OF SCIENTIFIC INQUIRY AND  
12 RESEARCH, THE DEGREE OF ENVIRONMENTAL BENEFITS, OR OTHER  
13 CONSIDERATIONS DEEMED APPROPRIATE TO PROMOTE SOIL HEALTH  
14 PRACTICES.

15 (b) THE DEPARTMENT SHALL NOT MAKE A GRANT UNLESS THE  
16 ADVISORY COMMITTEE APPROVES THE GRANT, INCLUDING THE AMOUNT,  
17 RECIPIENT, AND PURPOSE; EXCEPT THAT THE ADVISORY COMMITTEE MAY  
18 DELEGATE, WITH APPROVAL STANDARDS, TO THE DEPARTMENT APPROVAL  
19 OF THE TYPES OF GRANTS THAT ARE DETERMINED APPROPRIATE.

20 (3) ALL PROGRAMS ESTABLISHED UNDER SUBSECTION (1) OF THIS  
21 SECTION ARE VOLUNTARY AND INCENTIVE BASED. THE DEPARTMENT  
22 SHALL NOT REQUIRE:

23 (a) ELIGIBLE ENTITIES TO PARTICIPATE IN THE SOIL HEALTH  
24 PROGRAM; OR

25 (b) NONPARTICIPATING ENTITIES TO IMPLEMENT SOIL HEALTH  
26 PRACTICES.

27 (4) BEFORE ESTABLISHING A PROGRAM, THE DEPARTMENT SHALL

1 PROVIDE PUBLIC NOTICE ON THE AGENCY'S OFFICIAL WEBSITE. THE  
2 DEPARTMENT SHALL GIVE THE PUBLIC NO LESS THAN FORTY-FIVE DAYS TO  
3 SUBMIT WRITTEN COMMENTS AFTER THE DATE OF PUBLICATION ON ITS  
4 OFFICIAL WEBSITE.

5 **35-73-105. Powers and duties of the department.** (1) IN  
6 CARRYING OUT THIS ARTICLE 73, THE DEPARTMENT MAY:

7 (a) SEEK, ACCEPT, AND EXPEND GIFTS, GRANTS, OR DONATIONS  
8 FROM PRIVATE OR PUBLIC SOURCES FOR THE PURPOSES OF THIS ARTICLE  
9 73, BUT THE DEPARTMENT SHALL NOT PLEDGE THE FAITH OR CREDIT OF  
10 THE STATE OF COLORADO OR ANY COUNTY OR OTHER POLITICAL  
11 SUBDIVISION. IN CONNECTION WITH THE GIFTS, GRANTS, OR DONATIONS,  
12 THE DEPARTMENT MAY ENTER INTO AN AGREEMENT OR CONTRACT.

13 (b) ADMINISTER AND EXPEND THE FOLLOWING MONEY TO PLAN,  
14 DEVELOP, OR IMPLEMENT PROGRAMS AUTHORIZED IN SECTION 35-73-104:

15 (I) APPROPRIATIONS MADE BY THE GENERAL ASSEMBLY;

16 (II) MONEY GRANTED TO OR MADE AVAILABLE TO THE  
17 DEPARTMENT BY THE UNITED STATES GOVERNMENT, AN AGENCY OF THE  
18 UNITED STATES GOVERNMENT, OR A POLITICAL SUBDIVISION OF  
19 COLORADO;

20 (III) GIFTS, GRANTS, OR DONATIONS RECEIVED UNDER SUBSECTION  
21 (1)(a) OF THIS SECTION; OR

22 (IV) MONEY DERIVED FROM ANY OTHER SOURCE, SUBJECT TO  
23 APPROPRIATION;

24 (c) PROVIDE GRANTS, LOANS, AND OTHER RESOURCES TO ELIGIBLE  
25 ENTITIES TO PERFORM SOIL HEALTH ACTIVITIES;

26 (d) UNLESS OTHERWISE SPECIFIED BY THE GRANTOR OR DONOR,  
27 USE ANY MONEY RECEIVED FROM A POLITICAL SUBDIVISION OF COLORADO,

1 THE UNITED STATES GOVERNMENT, OR AN AGENCY OF OR CORPORATION  
2 OF THE UNITED STATES GOVERNMENT TO SERVE AS A MATCHING FUND FOR  
3 SOIL HEALTH ACTIVITIES; OR

4 (e) COOPERATE AND COLLABORATE, INCLUDING ENTERING INTO AN  
5 AGREEMENT, TO:


6 (I) ADVANCE THE SCIENTIFIC UNDERSTANDING OF SOIL HEALTH,  
7 SOIL HEALTH PRACTICES, ENVIRONMENTAL OUTCOMES, OR ECONOMIC  
8 OUTCOMES;

9 (II) INCREASE MONETARY OR NONMONETARY RESOURCES TO  
10 SUPPORT SCIENTIFIC RESEARCH; OR

11 (III) APPLY FOR GRANTS, INCLUDING APPLYING FOR GRANTS  
12 JOINTLY, AND OBTAIN RESOURCES TO SUPPORT THE PROGRAMS  
13 AUTHORIZED IN SECTION 35-73-104.

14 (2) IN ESTABLISHING A GRANT PROGRAM, THE DEPARTMENT SHALL:

15 (a) MAKE MONEY AVAILABLE FOR DEMONSTRATION PROJECTS,  
16 EDUCATIONAL PROJECTS, IMPLEMENTATION PROJECTS, OR RESEARCH  
17 PROJECTS GRANTS TO ELIGIBLE ENTITIES;

18   
19 (b) MINIMIZE THE USE OF MONEY BY GRANT RECIPIENTS FOR COSTS  
20 NOT DIRECTLY RELATED TO GRANT OUTCOMES, SUCH AS ADMINISTRATIVE  
21 EXPENSES OR OTHER EXPENSES RELATED TO OVERHEAD;

22 (c) ESTABLISH A MONITORING AND OVERSIGHT PROCEDURE TO  
23 ENSURE THAT MONEY IS BEING SPENT AS INTENDED; AND

24 (d) ESTABLISH PROTOCOLS THAT ENSURE THE CONFIDENTIALITY,  
25 IN ACCORDANCE WITH SECTION 35-73-107, OF AGRICULTURAL PRODUCER,  
26 LANDOWNER, LAND MANAGER, AND LAND INFORMATION, INCLUDING WITH  
27 RESPECT TO A STATE SOIL HEALTH INVENTORY AND PLATFORM AND STATE

3 **35-73-106. Soil health advisory committee - repeal.** (1) THE  
4 COMMISSIONER SHALL APPOINT A SOIL HEALTH ADVISORY COMMITTEE OF  
5 NO LESS THAN TEN MEMBERS.

6 (2) (a) THE COMMISSIONER SHALL APPOINT MEMBERS WHO:

7 (I) REPRESENT THE DIFFERENT GEOGRAPHIC AREAS AND  
8 DEMOGRAPHIC DIVERSITY OF THE STATE AND REFLECT THE POLITICAL  
9 DIVERSITY OF THE STATE, TO THE GREATEST EXTENT POSSIBLE;

10 (II) INCLUDE AGRICULTURAL PRODUCERS OF DIVERSE PRODUCTION  
11 SYSTEMS, INCLUDING DIVERSITY IN SIZE, PRODUCT, IRRIGATED SYSTEMS,  
12 DRYLAND SYSTEMS, AND LIVESTOCK PRODUCTION SYSTEMS; AND

13 (III) INCLUDE:

14 (A) AN IRRIGATED CROP PRODUCER;

15 (B) A DRYLAND CROP PRODUCER;

16 (C) A RANCHER;

17 (D) AN ORGANIC PRODUCER;

19 (F) A REPRESENTATIVE OF AN INDIAN TRIBE;

20 (G) A REPRESENTATIVE WITH EXPERTISE IN SOIL CARBON STORAGE  
21 AND NATURAL CLIMATE MITIGATION;

22 (H) TWO REPRESENTATIVES WHO ARE MEMBERS OF THE STATE  
23 CONSERVATION BOARD; AND

24 (I) AT LEAST TWO WATER USERS WHO OWN, LEASE, OR REPRESENT  
25 OWNERS OF ADJUDICATED WATER RIGHTS USED FOR AGRICULTURAL  
26 PURPOSES BOTH FROM WEST OF THE CONTINENTAL DIVIDE AND EAST OF  
27 THE CONTINENTAL DIVIDE, ONE OF WHOM MUST BE A DITCH CORPORATION

8 (2)(a)(III)(H) OF THIS SECTION.

9 (c) THE COMMISSIONER SHALL APPOINT ONE OF THE TWO

24 (4)(a) THE COMMISSIONER SHALL APPOINT APPROXIMATELY HALF  
25 OF THE INITIAL MEMBERS FOR TWO-YEAR TERMS, BUT THEREAFTER,  
26 APPOINTMENTS ARE FOR FOUR-YEAR TERMS UNLESS THE COMMISSIONER,  
27 IN CHANGING THE NUMBER OF MEMBERS, DETERMINES THAT AN

1 APPOINTMENT NEEDS TO BE FOR LESS THAN FOUR YEARS TO KEEP  
2 APPROXIMATELY HALF OF THE TOTAL NUMBER OF THE MEMBERS' TERMS  
3 EXPIRING EVERY TWO YEARS. UPON EXPIRATION OF A MEMBER'S TERM,

8 NOT A FULL TERM.

9 (5) THE COMMISSIONER MAY REMOVE A MEMBER OF THE  
10 ADVISORY COMMITTEE FOR MISCONDUCT, INCOMPETENCE, OR NEGLECT OF  
11 DUTY.

12 (6) A MAJORITY OF THE MEMBERS THAT REPRESENT AT LEAST FIVE  
13 OF THE PEOPLE OR GROUPS DESCRIBED IN SUBSECTIONS (2)(a)(III)(A) TO  
14 (2)(a)(III)(H) OF THIS SECTION CONSTITUTES A QUORUM OF THE ADVISORY  
15 COMMITTEE TO TAKE ANY ACTION AUTHORIZED IN THIS SECTION.

16 (7) (a) THE ADVISORY COMMITTEE SHALL:

17 (I) APPROVE OR DENY ANY GRANT PROPOSED BY THE DEPARTMENT  
18 OR DELEGATE, WITH APPROVAL STANDARDS, TO THE DEPARTMENT  
19 APPROVAL OF THE TYPES OF GRANTS THAT ARE DETERMINED  
20 APPROPRIATE; AND

21 (II) MAKE RECOMMENDATIONS TO THE DEPARTMENT CONCERNING  
22 AND ASSIST IN THE DEVELOPMENT OF THE SOIL HEALTH PROGRAM,  
23 INCLUDING RECOMMENDATIONS FOR THE QUALIFICATIONS OF ELIGIBLE  
24 ENTITIES TO RECEIVE GRANT MONEY.

25 (b) THE ADVISORY COMMITTEE MAY:

26 (I) SOLICIT INPUT FROM STAKEHOLDERS FROM EACH MEMBER'S  
27 AREA OF EXPERTISE AND REGION OF THE STATE AND COMMUNICATE THE


1 ADVISORY COMMITTEE'S RECOMMENDATIONS TO THE REGION AND  
2 STAKEHOLDERS REPRESENTED BY EACH MEMBER;

3 (II) SOLICIT INPUT, IN COLLABORATION WITH THE DEPARTMENT,  
4 FROM UNDERSERVED AGRICULTURAL PRODUCERS;

5 (III) SOLICIT INPUT FROM AGRICULTURAL PRODUCERS THAT  
6 REFLECT THE DIFFERENT GEOGRAPHIC AREAS AND DEMOGRAPHIC  
7 DIVERSITY OF THE STATE TO THE GREATEST EXTENT POSSIBLE;


8 (IV) REVIEW SOIL HEALTH GRANT PROPOSALS FROM GRANT  
9 APPLICANTS, INCLUDING PROPOSED BUDGETS, PROPOSED GRANT  
10 OUTCOMES, AND THE QUALIFICATIONS OF ANY ELIGIBLE ENTITIES  
11 APPLYING FOR GRANTS;

12 (V) REVIEW ANY AGREEMENTS FOR COOPERATION OR  
13 COLLABORATION ENTERED INTO BY THE DEPARTMENT AS AUTHORIZED IN  
14 SECTION 35-73-105 (1)(e);

16 (VI) EVALUATE THE RESULTS AND EFFECTIVENESS OF SOIL HEALTH
